#### **TRADE MARK ASSIGNMENT AGREEMENT**

**THIS TRADE MARK ASSIGNMENT AGREEMENT** (the "Agreement") is made on the 18 day of December 2019.

In consideration of the sum paid by the Assignee to the Assignor (the sufficiency and receipt of which such Assignor hereby acknowledges), the Assignor hereby assigns and transfers to the Assignee all of such Assignor's right, title and interest in and to the Trademarks (whether registered or unregistered) together with the whole of the goodwill in or to the Trademarks and including, without limitation, any rights to take action against any past infringement or breach in relation to the Trademarks.

1. The Assignor shall, at the request, cost and expense of the Assignee, promptly take such actions (including, without limitation, the prompt execution and delivery of documents in recordable form or testifying as to any material fact or thing) as may be necessary to vest in, record and secure unto Assignee the referenced right, title and interest in and to the Trademarks.

1. The Parties agree that this Agreement shall be governed by the laws of the State of Colorado.
