## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between **JPMorgan Chase Bank, N.A.** (“Grantee”), and **Brook Furniture Rental, Inc.** (“Grantor”), dated September 30, 2011 (the “Trademark Security Agreement”), Grantor granted to Grantee a continuing security interest in and to all of Grantor’s right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor (collectively, the “Trademarks”), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith;

**WHEREAS**, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Pledge and Security Agreement by and between Grantor and Grantee dated September 30, 2011 (the “Security Agreement”);

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 3, 2011, at Reel 4634, Frame 0699; and

**WHEREAS**, Grantor has requested that Grantee release its security interests in the Trademarks, and Grantee has agreed to release such security interests in exchange for payment of a release price acceptable to Grantee.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
