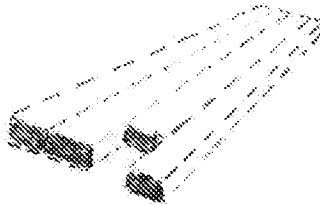


Whereas Assignor merged with a long-time partner, and the two companies rebranded the matting company, creating Yak Access, LLC ("Assignee").
