RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "Release") is made as of August 25, 2023 by **HSBC UK BANK PLC** a public limited company ("Lender"), in favor of **COMMERCE ONE, LLC**, a limited liability company of Delaware ("Pledgor").

WHEREAS, **HSBC BANK PLC** assigned its security interest in and to the Intellectual Property to Lender on February 24, 2022.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property, and hereby assigns and transfers to Pledgor any and all interest, if any, Lender may be deemed to have in and to the Intellectual Property under the Security Agreement.

Lender hereby authorizes Pledgor to record this Release with the United States Patent and Trademark Office and the United States Copyright Office.
