**RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATIONS**

Reference is hereby made to that certain Intellectual Property Security Agreement, dated as of December 31, 2020, executed by Manscaped, Inc., a Delaware corporation ("Grantor"), whose address is 3753 Howard Hughes Parkway, Suite 200 Las Vegas, NV 89169, in favor of FIRST-CITIZENS BANK & TRUST COMPANY (successor by purchase to the Federal Deposit Insurance Corporation as receiver for Silicon Valley Bridge Bank, N.A. (as successor to Silicon Valley Bank)) ("Bank"), which was recorded in the United States Patent and Trademark Office on December 31, 2020, at Reel 007151 Frame 0817 (the "Agreement"), and pursuant to which the Grantor assigned and granted to Bank a security interest in and to all of Grantor's right, title and interest in and to all of its Intellectual Property Collateral (as defined therein), including without limitation those trademarks specifically listed on Exhibit A attached hereto (the "Marks") and the goodwill associated therewith; and



NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Bank hereby terminates the Agreement and releases, retransfers and reassigns to Grantor without representation or warranty, any and all liens, security interests, right, title and interest of Bank in and to the Intellectual Property Collateral, including without limitation, the Marks and the goodwill associated therewith.
