**TERMINATION OF SECURITY INTEREST  
(TRADEMARKS)**

This **TERMINATION OF SECURITY INTEREST (TRADEMARKS)**, dated as of August 31, 2023 (this "Termination"), is made by OFS Agency Services, LLC, a Delaware limited liability company, as Agent under the IP Security Agreement referred to below (in such capacity, the "Agent").

WHEREAS, Milrose Consultants, LLC, a Delaware limited liability company (the "Grantor"), pledged, collaterally assigned and transferred to the Agent, and thereby granted to the Agent, for the benefit of the Secured Parties, a security interest in certain personal property, including without limitation, a security interest in the Trademark Collateral pursuant to that certain Trademark Security Agreement dated as of December 14, 2021 (as amended, restated, supplemented and otherwise modified from time to time, the "IP Security Agreement"; all capitalized terms used herein and not defined shall have the meanings set forth in the IP Security Agreement);

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office on December 21, 2021 at Reel 7537, Frame 0393; and

WHEREAS, the Agent has agreed to terminate and release its security interest in the Trademark Collateral as herein provided.

NOW, THEREFORE, for valuable consideration, the Agent without representation or warranty of any kind, hereby absolutely, unconditionally and irrevocably terminates, releases and discharges, any and all liens and security interests granted to the Agent as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Secured Obligations in the Trademark Collateral, including without limitation the Trademarks and Trademark Licenses referred to on Schedule I.

The Agent hereby authorizes Grantor (or its authorized representative or agent) to file this document along with any other necessary documentation with the United States Patent and Trademark Office to evidence the termination and release granted herein.

THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REFERENCE TO CONFLICTS OF LAW PROVISIONS.
