**TERMINATION AND RELEASE OF AMENDED AND RESTATED TRADEMARK  
SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of August 29, 2023, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Grantee"), to **REVEAL DATA CORPORATION**, a Delaware corporation, and **BRAINSPACE CORPORATION**, a Texas corporation (each a "Grantor", and collectively the "Grantors").

WHEREAS, in connection with that certain Revolving Credit, Term Loan and Security Agreement, by and among the Grantors, the Grantee, and certain other parties, dated as of March 9, 2022 (as may have been amended restated, supplemented or otherwise modified prior to the date hereof, the "Credit Agreement"), the Grantors executed and delivered that certain Amended and Restated Trademark Security Agreement dated as of November 15, 2022, made by Grantors in favor of Grantee (the "Trademark Security Agreement"), which amended and restated in its entirety a Trademark Security Agreement recorded with the United States Patent and Trademark Office with the trademark division at Reel/Frame 007654/0175 (the "Original Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on November 16, 2022, at Reel/Frame 007923/0367;

WHEREAS, Grantee now desires to terminate the Trademark Security Agreement and terminate, release and discharge its security interest in the Trademark Collateral, including without limitation, the trademarks and trademark applications set forth on Exhibit A attached hereto;


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement or the Trademark Security Agreement, as applicable.
2. Release of Security Interest. Grantee and its respective successors, indorsees, transferees and assigns, hereby terminates the Trademark Security Agreement and terminates, releases and discharges its continuing first priority security interest in all of the Grantor's right, title, and interest to, and under the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral.
