## **RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY**


THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (“Release”) is made as of this 30<sup>th</sup> day of August 2023, by Middlesex Bank, a Massachusetts banking corporation (“Bank”), in favor of Walpole Outdoors LLC, a Delaware limited liability company (“Grantor”). Capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the applicable IP Security Agreement (hereinafter defined).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Bank hereby terminates, releases, and fully discharges all liens and security interests granted by the Grantor in favor of Bank pursuant to (i) that certain Patent Security Agreement, dated as of February 27, 2019 (the “Patent Security Agreement”), (i) that certain Trademark Security Agreement, dated as of February 27, 2019 (the “Trademark Security Agreement” and, together with the Patent Security Agreement, each, individually, an “IP Security Agreement” and, collectively, the “IP Security Agreements”), executed by the Grantor in favor of Bank and recorded with the United States Patent and Trademark Office (i) on March 21, 2019, at Reel/Frame 006685/0237, including without limitation all liens and security interests in the trademarks listed on Schedule A attached hereto, and (ii) on March 26, 2019, at Reel/Frame 048703/0281, including without limitation all liens and security interests in the patents listed on Schedule B attached hereto.
