SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement to Intellectual Property Security Agreement (this “*Supplement*”) is made as of September 7, 2023 by and between **FIRST-CITIZENS BANK & TRUST COMPANY** (successor by purchase to the Federal Deposit Insurance Corporation as receiver for Silicon Valley Bridge Bank, N.A. (as successor to Silicon Valley Bank) (the “*Agent*”), and **MIVA, INC.**, a California corporation (as “*Grantor*”).

WHEREAS, Grantor executed and delivered an Intellectual Property Security Agreement dated October 15, 2021 (as amended of record from time to time hereinafter, the “*IP Agreement*”) in favor of the Agent, pursuant to which Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral, which was recorded with the Trademark division of the United States Patent and Trademark Office on October 20, 2021 at Reel 7462, Frame 0902.

WHEREAS, the Grantor has developed additional patents, and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional intellectual property in favor of the Agent.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. **Definitions**. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the IP Agreement.
2. **Supplement to Exhibit C**. **Exhibit C** to the IP Agreement is hereby supplemented, but not replaced, by **Exhibit C-1** annexed hereto.
3. **Miscellaneous**:
 - a. Except as provided herein, all terms and conditions of the IP Agreement remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
