TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), entered into as of July 21, 2023, is made by DBI Investors, Inc. (the "Company") and the subsidiaries of the Company that are indicated on the signature pages attached hereto (together with the Company, each an "Assignor" and collectively, "Assignors") to David's Bridal, Inc., a Delaware corporation ("Assignee"). Capitalized terms used, but not defined, in this Assignment have the meanings set forth in the Purchase Agreement.

WHEREAS, Assignors, Assignee, David's Canada Inc., an Ontario corporation and CION Investment Corporation, a Maryland corporation have executed an Asset Purchase Agreement, effective July 14, 2023 (the "Purchase Agreement"), pursuant to which each Assignor agreed to assign to Assignee all of Assignor's entire worldwide right, title and interest in, to and under all Seller Intellectual Property, including the trademarks and trademark applications listed on Exhibit A attached hereto, including all issuances, extensions, and renewals thereof (collectively, the "Assigned Trademarks");

WHEREAS, Assignee is a successor to that part of each Assignor's business to which the Assigned Trademarks pertain, and that business is ongoing and existing; and

WHEREAS, pursuant to the Purchase Agreement, Assignors have agreed to execute this Assignment in order to effectuate, evidence and record its assignment of the Assigned Trademarks to Assignee in the United States Patent and Trademark Office and corresponding offices in other applicable jurisdictions.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to the terms and conditions of the Purchase Agreement and the Sale Order, the Assignors and Assignee agree as follows:

1. Assignment. Each Assignor hereby irrevocably sells, conveys, assigns, transfers and delivers to Assignee, and Assignee hereby accepts and receives, free and clear of all Encumbrances (other than Permitted Encumbrances), all of such Assignor's entire worldwide right, title and interest in and to the Assigned Trademarks, together with all goodwill associated with the Assigned Trademarks and any and all common law rights in and to the Assigned Trademarks, all rights in and to the Assigned Trademarks provided by international treaties or conventions, all rights, interests, and claims of such Assignor or any of its affiliates, all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to the Assigned Trademarks, all of such Assignor's claims, causes of actions, and rights to sue or otherwise recover for any past, present, or future infringement, dilution or other violations of the Assigned Trademarks, including the right to sue for, collect, and retain all damages, profits, proceeds, and all other remedies associated therewith and to obtain equitable relief, whether accruing before, on, or after the date hereof, and the right to any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing, in each case of the foregoing, all said rights to be held and enjoyed by Assignee for its own use and enjoyment and for the use

and enjoyment of its successors and assigns to the full end of the term of the Assigned Trademarks as fully and entirely as the same would have been held by Assignors had this assignment and sale not been made.

2. Recordation. Each Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee. Each Assignor also does hereby grant to Assignee, its successors and assigns, and legal representatives thereof, the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office or foreign equivalent thereof for recordation of this document. Following the date hereof, each Assignor shall, at Assignee's request and expense, take such reasonable steps and actions, and provide such reasonable cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, notarizations, apostilles, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, record, or perfect the assignment of the Assigned Trademarks to Assignee or any assignee or successor thereto.

3. Terms of Purchase Agreement. This Assignment is executed and delivered pursuant to, and is expressly made subject to the terms of, the Purchase Agreement. In the event of a conflict between the terms and conditions of this Assignment and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall govern, supersede and prevail in all respects to the extent of such conflict. Notwithstanding anything to the contrary in this Assignment, nothing herein is intended to, nor shall this Assignment be construed to, amend, supersede, replace, extend, amplify, modify, limit, waive or otherwise alter in any way the terms and conditions of the Purchase Agreement (including, without limitation, any representation, warranty, covenant or obligation contained in the Purchase Agreement) or any of the rights, remedies or obligations of Purchaser or Sellers provided for therein or arising therefrom in any way, all of which shall remain in full force and effect in accordance with their terms), which shall not be merged with or into this Assignment but shall survive the execution and delivery of this Assignment to the extent, and in the manner, set forth in the Purchase Agreement.

4. Further Assurances. The terms set forth in Section 6.6 (Further Assurances) of the Purchase Agreement are incorporated by reference herein, except that, as applicable, any and all references to "this Agreement" shall mean and refer to this Assignment.


5. Miscellaneous. The terms set forth in Section 10.3 (Notices), Section 10.4 (Binding Effect; Assignment), Section 10.5 (Amendment and Waiver), Section 10.6 (Third Party Beneficiaries), Section 10.8 (Severability), Section 10.9 (Construction), Section 10.13 (Jurisdiction and Exclusive Venue), Section 10.14 (Governing Law; Waiver of Jury Trial) and Section 10.16 (Counterparts and PDF) of the Purchase Agreement are incorporated by reference herein, except that, as applicable, any and all references to "this Agreement" shall mean and refer to this Assignment.
