RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “*Release*”) is made as of September 7, 2023, by ING Capital LLC, as collateral agent (in such capacity, the “*Collateral Agent*”).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 31, 2022 by and among Perdue Foods LLC, Perdue Agribusiness LLC, Perdue Agribusiness Grain LLC, Perdue Farms Inc., Maxi Canada Inc., Perdue Premium Meat Company, Inc. and Sioux-Preme Packing Co. (collectively, jointly and severally, the “*Grantors*”) the Grantors have granted to the Collateral Agent a security interest in its trademarks, including but not limited to, the trademarks set forth in Schedule 1 (such trademarks set forth on Schedule 1, the “*Trademarks*”);

WHEREAS, the above referenced Trademark Security Agreement was recorded at Reel 7729, Frame 0031 on May 20, 2022; and

WHEREAS, the Grantors have requested that the Collateral Agent release its lien on the Trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases any and all claims, liens, and other encumbrances in and to the Trademarks and reassigns any and all rights, titles and interests therein, without any representation, recourse or undertaking by the Collateral Agent, to the Grantors.


