CERTIFICATE OF MERGER**

Pursuant to the Delaware General Corporation Law (the “**DGCL**”), the undersigned submits and certifies the following Certificate of Merger for the purpose of effecting a merger among a domestic corporation, a foreign limited liability company and a foreign corporation.

- FIRST:** The name of the surviving corporation is Massman Companies, Inc., a Delaware corporation (the “**Surviving Corporation**”), and the names of the entities being merged with and into the Surviving Corporation are: (i) Massman Automation Designs, LLC, a Minnesota limited liability company and (ii) New England Machinery, Inc., a Minnesota corporation; ((i) and (ii), each, a “**Merging Company**,” and collectively, the “**Merging Company**”).
- SECOND:** The Agreement and Plan of Merger (the “**Agreement**”) has been approved, adopted, certified, executed and acknowledged by the Surviving Corporation and each Merging Company.

- SEVENTH:** The Certificate of Incorporation of the Surviving Corporation shall be its Certificate of Incorporation.
