## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of September 8, 2023, by Apogem Capital LLC (as successor-in-interest to Madison Capital Funding LLC), with principal offices at 227 West Monroe Street, Suite 5400, Chicago, IL 60606, in its capacity as agent for the benefit of the financial institutions (the “Lenders”) that are parties to the Credit Agreement referenced in the Security Agreement referenced below (in such capacity, “Agent”), to Elgin Fastener Group, LLC (“Grantor”).

### WITNESSETH

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of April 1, 2013 (as amended to date, the “Security Agreement”), made by Grantor in favor of Agent, a security interest was granted by Grantor to Agent in the Trademark Collateral as such term is defined in the Security Agreement, including without limitation those items listed on Schedule A hereto;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on April 2, 2013, at Reel 4996, Frame 0831 and in the Assignment of Intellectual Property Security Agreement from Madison Capital Funding LLC to Apogem Capital LLC on April 15, 2022 at Reel 7693, Frame 0582; and

WHEREAS, Grantor desires Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent, on behalf of the Lenders, hereby terminates, releases, and discharges unto Grantor the continuing security interest in, and any other interest Agent and Lenders may have in, Grantor’s right, title, and interest in, to, and under the Trademark Collateral.

The Agent authorizes and requests that the Commissioner for Trademarks, and any other applicable government officer, record this Release.


This Release and its rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with the laws of the State of Illinois.
