**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK, PATENT AND COPYRIGHT COLLATERAL**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of September 5, 2023, is made by JPMorgan Chase Bank, N.A., in its capacity as collateral agent (the "Collateral Agent"), in favor of (i) Black Knight IP Holding Company, LLC, a Delaware limited liability company, and (ii) Swiftview, LLC, an Oregon limited liability company, (each, a "Grantor" and collectively, the "Grantors"), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement, dated as of May 27, 2015 (as amended, restated, amended and restated, supplemented and restructured or otherwise modified, renewed or replaced from time to time, the "Security Agreement"), among the Grantors and the other parties party thereto, in favor of the Collateral Agent, the Grantors entered into those certain Intellectual Property Security Agreements listed in Annex I attached hereto (collectively, the "IP Security Agreements");

WHEREAS, each Grantor granted to Collateral Agent, under the terms of the IP Security Agreements, a security interest in favor of Collateral Agent in all of the Grantors' and certain other parties' right, title, and interest in and to the IP Collateral (as defined in each IP Security Agreement), in favor of the Collateral Agent; and

WHEREAS, the Collateral Agent now desires to terminate and release the IP Security Agreements and the entirety of its security interest in all of the IP Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "IP Collateral", as used herein, shall include all of the Grantors' right, title and interest in, to and under all IP Collateral in each IP Security Agreement, including without limitation all of the trademarks (together with all associated goodwill), patents and copyrights listed on Annex II attached hereto. Capitalized terms used, but not otherwise defined herein, shall have the meanings set forth in the Security Agreement or the applicable IP Security Agreement, as applicable.

2. Release of Security Interest. The Collateral Agent, without recourse, representation or warranty and at the Grantors' sole cost and expense, hereby terminates, cancels, releases, relinquishes, discharges and reassigns to each Grantor, in its entirety, for the benefit of such Grantor and their successors and assigns, its security interest in and to the IP Collateral and hereby terminates and releases the IP Security Agreements described in Annex I attached hereto. Any and all right, title and interest of the Collateral Agent in, to and under the IP Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. The Collateral Agent hereby authorizes each Grantor and its successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office and the United States Copyright Office, and/or otherwise record or file this Release with the applicable government office or agency, at the sole expense of such Grantor, to evidence and effectuate the release and termination of the Collateral Agent's security interest in the IP Collateral. Collateral Agent further agrees to execute and deliver to Grantors, or each Grantor, any and all further documents and instruments, and do any and all further acts which Grantors (or their agents or designees) reasonably requests (at Grantors' sole cost and expense) in order to confirm, effectuate or record this Release and each Grantor's rights, title and interest in, to and under the IP Collateral.


