RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of this 29th day of August, 2023, by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as agent for each member of the Secured Parties ("Agent"), in favor of MSC INFORMATION RETRIEVAL TECHNOLOGIES B.V., a Netherlands besloten vennootschap, MSC INTELLECTUAL PROPERTIES B.V., a Netherlands besloten vennootschap, ZYLAB TECHNOLOGIES B.V., a Netherlands besloten vennootschap, ZYLAB DISTRIBUTION B.V., a Netherlands besloten vennootschap, ZYLAB BENELUX B.V., a Netherlands besloten vennootschap, and ZYLAB EDISCOVERY & COMPLIANCE SERVICES (DCS) B.V., a Netherlands besloten vennootschap (each a "Grantor", and collectively, the "Grantors"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WHEREAS, the Grantors and Agent entered into that certain Trademark Security Agreement, dated as of dated as of September 15, 2021 (the "Security Agreement") pursuant to which each Grantor granted, collaterally assigned and pledged to Agent, for the benefit of the Secured Parties, to secure the Secured Obligations, a continuing security interest in all of such Grantor's right, title and interest in and to the following Trademark Collateral, whether then owned or thereafter acquired or arisen (collectively, the "Trademark Collateral"):

- (a) all of its U.S. Trademarks and Trademark Intellectual Property Licenses to which it is a party, including those registered or applied for Trademarks referred to on Schedule A;
- (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and

(c) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License.

WHEREAS, the Security Agreement was recorded with (i) the United States Patent and Trademark Office on September 15, 2021 at Reel/Frame 7422/0487.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby terminates the Security Agreement and absolutely, unconditionally and irrevocably terminates and releases all liens and Security Interest (as defined in the Trademark Security Agreement) granted by the Grantors in favor of Agent in the Trademark Collateral pursuant to the Security Agreement.
