WHEREAS, Assignor desires to transfer to Assignee all right, title, and interest in and to the Assigned Marks as described herein; and


WHEREAS, Assignee desires to accept the transfer of all rights, title, and interest in and to the Assigned Marks.

1. Assignment. Assignor hereby irrevocably conveys, transfers and assigns to Assignee all of Assignor's right, title and interest in and to the Assigned Marks, including all goodwill of the business connected with the use of, and symbolized by the Assigned Marks. As of the Effective Date, Assignor shall not retain any of the foregoing rights.
2. Costs. Assignee shall assume and be responsible for all costs related to the prosecution, maintenance, and enforcement of the Assigned Marks incurred as of and after the Effective Date.
3. Warranties and Representations. Assignor hereby warrants and represents that: (a) at the time of execution of this Assignment, Assignor is and was the lawful owner of the entire right, title, and interest in and to the Assigned Marks; and (b) Assignor has not entered into any assignment, contract or understanding in conflict herewith.
