## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is dated as of May 31, 2021 and is from Future Festivals, LLC, a Delaware limited liability company ("Assignor") to Coachella Music Festival, LLC, a Delaware Limited Liability Company ("Assignee").

WHEREAS, Assignor has adopted, used and is using in the conduct of its business the trademarks "ARROYO SECO WEEKEND" and "DESERT TRIP" (collectively, the "Festival Trademarks").

WHEREAS, Assignor and Assignee have entered into that certain letter agreement dated as of April 9, 2021 by and among Assignor, Assignee and others (the "Letter Agreement") and the Assignment and Assumption Agreement by and among Assignor and Assignee whereby Assignor has agreed to assign and convey to Assignee certain assets including, without limitation, the Trademarks and their associated goodwill.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignment. Effective as of the Effective Date, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest in and to the Festival Trademarks, the trademark registrations and applications set forth on Schedule I hereto and all issuances, extensions, and renewals thereof (the "Trademarks"), together with the goodwill of the business(es) connected with the use of, and symbolized by, the Trademarks; and with all claims arising out of or relating to the use or ownership of the Trademarks.
2. Recordation and Further Actions. Assignor authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment upon request by Assignee. Following the date hereof, each party shall take such action (including, but not limited to, the execution, acknowledgment and delivery of assignments, instruments of transfer and conveyance, and other documents) as may be reasonably requested by the other party to evidence, perfect or effect the requesting party's rights as set forth in this Trademark Assignment. This Assignment may be executed via wet signatures or DocuSign and in one or more counterparts and delivered by email or by facsimile, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement.
