TERMINATION OF TRADEMARK SECURITY AGREEMENTS

This TERMINATION OF TRADEMARK SECURITY AGREEMENTS is made as of September 7, 2023, by CCP AGENCY, LLC as Agent for the Secured Persons (in such capacity, “Agent”), in favor of the entities identified as grantors in the Trademark Security Agreements (as defined below) (each individually, a “Grantor” and collectively, the “Grantors”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms or incorporated by reference in the Collateral Agreement or the Trademark Security Agreements, as applicable (each defined below).

WITNESSETH:

WHEREAS, reference is made to the Collateral Agreement dated as of November 30, 2022 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among each of the Grantors, the other grantors party thereto and the Agent, pursuant to which the Grantors assigned and pledged to the Agent, for the benefit of the secured creditors, a security interest in or to the Trademark Collateral;

WHEREAS, reference is also made to (i) that certain Trademark Security Agreement, dated as of December 20, 2022, made by JGW Lending, LLC in favor of the Agent, which was recorded with the Trademark Division of the United States Patent and Trademark Office on December 20, 2022, at Reel 7925 and Frame 0746 and (ii) that certain Trademark Security Agreement, dated as of November 30, 2022 made by the Grantors in favor of the Agent, which was recorded with the Trademark Division of the United States Patent and Trademark Office on November 30, 2022, at Reel 7904 and Frame 0216 (each as amended, restated, supplemented or otherwise modified from time to time, a “Trademark Security Agreement” and collectively, the “Trademark Security Agreements”), pursuant to which the Grantors granted the Agent a Lien in all right, title or interest in the Trademark Collateral (as defined in each Trademark Security Agreement); and

WHEREAS, the Grantors have satisfied and fulfilled all of their obligations to release the Agent’s security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth herein, the Agent hereby states as follows:

1. The term “Trademark Collateral” as used herein, shall have the meaning assigned thereto in each Trademark Security Agreement, and, for the avoidance of doubt, shall include the Trademarks listed on Schedule I hereto, pledged by each Grantor pursuant to the Trademark Security Agreement and the Collateral Agreement. The term “Trademarks” shall have the meaning provided by reference in the Collateral Agreement.

2. The Agent (on behalf of the secured creditors), hereby confirms effective as of the date hereof that (a) the Trademark Security Agreements are terminated, (b) the Agent, on behalf of the secured creditors, hereby terminates, cancels, releases and discharges any and all security

interests it has in or to the Trademark Collateral, including under the Collateral Agreement and the Trademark Security Agreements, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void, and (c) at the Grantors' expense, the Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably requested by the Grantors to effect the termination and release of the security interest contemplated hereby and authorizes the Grantors or their designee to take such actions.
