**RELEASE OF TRADEMARK SECURITY
AGREEMENT**

This RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of [September 1], 2023 (the “Release”), is made by CIBC Bank USA in its capacities as collateral agent or consignment collateral agent, as applicable, for each of the Financial Participants (together with its successors and assigns, the “Agent”), in connection with the termination of that certain Trademark Security Agreement (the “Security Agreement”) dated as of June 15, 2022 made by APMEX LLC (f/k/a APMEX, Inc.) (the “Grantor”), in favor of the Agent. Capitalized terms not defined herein shall have the meaning ascribed to them in the Security Agreement.

WITNESSETH

WHEREAS, pursuant to the Security Agreement, which was recorded with the U.S. Patent and Trademark Office on June 15, 2022 at Reel 007753/Frame 0001, the Grantor granted the Agent a security interest in, and lien on, the Trademark Collateral (as such term is defined in the Security Agreement), including the Trademarks listed in Schedule I hereto (the “Collateral”);

WHEREAS, the Grantor has requested that the Agent enter into this Release in connection with the termination of the Security Agreement.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby (i) releases, without representation, warranty or recourse, all of its and their security interests and liens in and to the Collateral, including without limitation the Collateral listed on Schedule I attached hereto and incorporated herein by reference, (ii) terminates the Security Agreement, and (iii) if and to the extent the Agent has acquired any right, title or interest in, to or under the Collateral, re-assigns to Grantor any right, title and interest it or they have in, to and under the Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
