RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of July 30, 2023, (this “Release”) is made by DFJ ELEMENT, L.P., a Delaware limited Partnership, in its capacity as collateral Agent (“Agent”) under the Pledge and Security Agreement (as amended, supplemented or modified and in effect from time to time, the “Security Agreement”), between A-TURF, INC., a New York corporation, SURFACE AMERICA, INC., a New York corporation, ECORE INTERNATIONAL INC., a Pennsylvania corporation, SPECTRASYSTEMS, INC., a Pennsylvania corporation, DODGE DELAWARE INC., a Delaware corporation, and DODGE REALTY PARTNERS, LP, a Pennsylvania limited Partnership (each a “Grantor” and collectively the “Grantors”) and the Agent. Capitalized terms used but not defined herein have the meanings provided in the Security Agreement.

WHEREAS, pursuant to the Security Agreement which was recorded at the United States Patent and Trademark Office on September 8, 2016 at Reel 039955 and Frame 0334, and recorded at the United States Patent and Trademark Office on September 8, 2016 at Reel 5872 and Frame 0368, the Grantors granted to the Agent a continuing security interest in all of Assignor’s right, title and interest in Intellectual Property, including those set forth on the attached Schedule I.


WHEREAS, Grantors have requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Intellectual Property Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Released Collateral, and (d) reassigns, grants and conveys to Grantor any and all right, title and interest it has in the Released Collateral.
