INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT AGREEMENT

This Intellectual Property Right Assignment Agreement (the "**Agreement**") is made and entered into by and between

(the "**Assignee**")

(hereinafter referred to collectively as "**the Parties**")

PREAMBLE

Assignor owns the entire right, title and interest in and to the flooring brands CORAL, FLOTEX, NUWAY and TESSERA, including, in the broadest sense of the terms possible, registered or unregistered trademarks, domain names, patents and copyrights related to the brands (collectively the "**Intellectual Property Rights**"). The Intellectual Property Rights particularly, but not exclusively, include the trademark registrations and trademark applications listed in the attached Schedule A (whether registered in the name of the Assignor or not).

Assignee desires to acquire all of Assignor's right, title and interest in and to the Intellectual Property Rights together with all the goodwill of the business symbolized thereby, and Assignor desires to assign all such right, title and interest in and to the Intellectual Property Rights to Assignee together with all the goodwill of the business symbolized thereby, upon the terms and conditions set forth in this Agreement.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by the Assignor, the Parties agree as follows:

Article 1. Assignment

Assignor wishes to assign and assigns to the Assignee, and Assignee hereby accepts from the Assignor, all of the Assignor's right, title and interest in and to the Intellectual Property Rights together with the goodwill of the business relating to the Intellectual Property Rights in consideration for payment of the purchase price outlined in Schedule B. The date of the assignment (the "**Effective Date**") will be March 1, 2022.

Article 2. Recordal Procedure

If the Assignee deems it necessary or desirable to record the assignment of a part (or all) of the Intellectual Property Rights with competent authorities, the Assignee shall prepare and the Assignor shall execute any and all additional documents needed for this purpose. Subsequently, Assignee shall request the recordal of the assignment of the Intellectual Property Rights with the competent authorities. Any official fees and/or third party expenses accruing in connection with the preparing and filing of such requests and any action required ancillary thereto shall be borne solely by the Assignee.

This Agreement shall be governed by and construed under the laws of Switzerland, without giving effect to the conflicts of laws provision thereof, and with the exclusion of the Vienna Convention on the International Sale of Goods. Any claim or dispute arising out of or relating to this Agreement that cannot be resolved amicably between the Parties within thirty (30) days after the controversy has arisen shall be subject to the exclusive jurisdiction of the courts located in Zurich (city), Switzerland.




