**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of September 1, 2023, and made by **PNC BANK, NATIONAL ASSOCIATION** (together with its successors and assigns, the "Agent"), to **I.O.W.A., LLC**, a California limited liability company, and **MEDIASILO, INC.**, a Delaware corporation (each a "Grantor" and collectively, the "Grantors").

WHEREAS, pursuant to (i) that certain Trademark Security Agreement dated as of November 16, 2018, made by Grantors in favor of the Agent (the "Initial Security Agreement") and (ii) that certain Supplement to the Security Agreement, dated as of October 18, 2022 (the "Security Agreement Supplement" and together with the Initial Security Agreement, collectively, the "Security Agreement") a security interest was granted by the Grantors to the Agent in certain collateral, including the federally registered trademarks referred to on Exhibit A hereto (collectively, the "Trademark Collateral");

WHEREAS, the Initial Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on November 19, 2018, at Reel/Frame 6484/0450;

WHEREAS, the Security Agreement Supplement was recorded with the trademark division of the United States Patent and Trademark Office on October 18, 2022, at Reel/Frame 7915/0248;

WHEREAS, the Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Agent hereby states as follows:

1. Definitions. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Initial Security Agreement and Security Agreement Supplement, as applicable.

2. Release of Security Interest. The Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in all of the Grantors' right, title and interest of every kind and nature in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of the Agent (if any), in, to and under the Trademark Collateral.
