**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”), is made effective as of September 12, 2023, by PNC BANK, NATIONAL ASSOCIATION, as Administrative Agent (the “**Administrative Agent**”), in favor of ICF INTERNATIONAL, INC., a Delaware corporation (“**ICFI**”), ICF CONSULTING GROUP, INC., a Delaware corporation (“**ICFC**”), ICF RESOURCES, L.L.C., a Delaware limited liability company (“**ICF Resources**”), ICF MACRO, INC., a Delaware corporation (“**ICF Macro**”), and ICF NEXT, INC., a Minnesota corporation (“**ICF Next**”, and together with ICFI, ICFC, ICF Resources, and ICF Macro, each a “**Grantor**”, and collectively, the “**Grantors**”).

WHEREAS, pursuant to that certain (i) Security Agreement, dated as of May 6, 2022 (as amended, supplemented, amended and restated or otherwise modified from time to time, the “**Security Agreement**”), by and among, *inter alia*, Grantors and Administrative Agent and (ii) that certain Trademark Security Agreement, dated as of May 6, 2022 (as amended, supplemented, amended and restated or otherwise modified from time to time, the “**TSA**”), by and among Grantors and Administrative Agent, Grantors mortgaged, pledged and hypothecated to the Administrative Agent, and granted to the Administrative Agent a security interest in, for its benefit and the benefit of each Secured Party, the Trademark Collateral, including the trademarks described on Schedule A hereto (the trademarks described on Schedule A hereto, collectively, the “**Released Trademarks**”);

WHEREAS, the TSA was recorded in the United States Patent and Trademark Office on May 30, 2022, at Reel 7737 / Frame 0096;

WHEREAS, the Released Trademarks have been sold in connection with that certain Asset Purchase Agreement, dated as of July 21, 2023 (the “**Purchase Agreement**”), by and among Experience & Engagement, LLC, a Delaware limited liability company, as buyer (“**Buyer**”), ICF Resources, ICF Next and ICF Next North America, Inc., an Ontario, Canada corporation and a wholly-owned subsidiary of ICF Next; and

WHEREAS, Administrative Agent wishes to release its security interest in the Released Trademarks and the Trademark Collateral associated with the Released Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Administrative Agent hereby agrees as follows:

1. **Definitions.** Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement and TSA, as applicable.

2. **Release.** Administrative Agent, without warranty as to status of title or priority of the encumbrances being hereby released, hereby releases, discharges, terminates and cancels all right, title and interest it has or may have in each of the Released Trademarks and the Trademark Collateral associated with the Released Trademarks, including, without limitation, any security interest it may have in such Released Trademarks and the Trademark Collateral associated with the Released Trademarks. This Release shall not have any effect with respect to any Trademark Collateral other than the Released Trademarks and the Trademark Collateral associated with the Released Trademarks, and shall not affect the TSA or any rights, titles, interests and security interests granted thereby (all of which shall continue

in full force and effect), except as explicitly provided in this Release with respect to the Released Trademarks and the Trademark Collateral associated with the Released Trademarks.

3. Recordation. Administrative Agent authorizes the filing of this Release with the United States Patent and Trademark Office, at the sole expense of Grantors, to evidence and effectuate the release of the Released Trademarks and the Trademark Collateral associated with the Released Trademarks.

4. Choice of Law. This Release shall be governed by and construed in accordance with the internal Laws of the State of New York without regard to its conflict of laws principles.
