Affidavit to Request Correction of Name Change

Pursuant to Trademark Manual of Examining Procedure (TMEP) Section 503.06(c), the current owner of United States Registration Nos. 5387228 and 5387124 (“the Subject Registrations”), Telefonaktiebolaget LM Ericsson, the prior owner of the Subject Registrations, and Red Bee Media Limited, the current owner of the Subject Registrations, request that the name change recorded on April 11, 2018 at Reel/Frame No. 6355/0115 be corrected. On the date that the name change was executed, November 8, 2017, the owner of the Subject Registrations was Telefonaktiebolaget LM Ericsson. The name change indicated that Ericsson Media Services UK Limited changed its name to Red Bee Media Limited, a transaction that did not affect the Subject Registrations. The rightful owner of the Subject Registrations on the execution date of November 8, 2017 was Telefonaktiebolaget LM Ericsson, not Ericsson Media Services UK Limited, such that the name change in question had no bearing or effect upon the Subject Registrations. The Subject Registrations were subsequently assigned to Red Bee Media Limited, a transaction that was recorded on December 20, 2017 at Reel/Frame No. 6232/0351. Unfortunately, the assignee in the assignment document was erroneously set forth as Ericsson Media Services UK Limited, and this error is being corrected in a corrective document being submitted in conjunction with this name change correction.

For avoidance of doubt, the correct chain of title for the Subject Registrations is: Telefonaktiebolaget LM Ericsson to Red Bee Media Limited, executed on December 12, 2017 and recorded on December 20, 2017 at Reel/Frame No. 6232/0351, and corrected in a coordinated filing in conjunction with this filing.

The undersigned attorney has firsthand knowledge of the facts, as the facts related to ownership, and the timing of ownership, are all publicly available and accessible on the USPTO website.
