

ASSIGNOR further covenants that, upon each reasonable request by Assignee, without additional consideration, Assignor shall promptly execute all commercially reasonable documents, papers, forms and authorizations and take all other actions that may be reasonably necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Trademarks, including, but not limited to, recording Assignee as the owner of the Trademarks with the United States Patent and Trademark Office.

This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same agreement. Facsimile signatures by either party shall be deemed effective and binding.
