INTELLECTUAL PROPERTY SECURITY AGREEMENT

September 20, 2023

WHEREAS, **SIGNAL HOUND, LLC**, a Washington limited liability company (the “Grantor”), is a party to that certain Loan and Security Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the “Loan Agreement”; capitalized terms used herein without definition shall have the meanings set forth in the Loan Agreement), among the Grantor, the other Loan Parties from time to time party thereto and CIBC BANK USA (“Lender”), pursuant to which the Grantor has pledged and granted to Lender a security interest in all of the Grantor’s right, title and interest in, to and under all of its personal property, including without limitation the Patents and Trademarks listed on Schedule A hereto; and

WHEREAS, it is a condition to the advance of the loans and other obligations secured by the Loan Agreement that the Grantor execute and deliver, and cause to be filed in the United States Patent and Trademark Office, this Intellectual Property Security Agreement (this “Intellectual Property Security Agreement”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

As collateral security for the payment in full when due (whether at stated maturity, by acceleration or otherwise) of the Obligations, the Grantor hereby pledges and grants to the Lender a security interest in all of the Grantor’s right, title, and interest in, to and under all of the Patents and Trademarks, whether now owned or hereafter acquired and whether now existing or hereafter coming into existence, of the Grantor that are issued by or filed with the United States Patent and Trademark Office, including the Patents and Trademarks listed on Schedule A hereto.

At such time as the Obligations have been Paid in Full and all Commitments of Lender under the Loan Agreement have terminated, at the sole expense of the Grantor, Lender shall execute and deliver to the Grantor such documents as the Grantor shall reasonably request to evidence the termination of this Intellectual Property Security Agreement and the security interest created hereby.

Notwithstanding the foregoing, in the event of any conflict between this Intellectual Property Security Agreement and the Loan Agreement, the Loan Agreement shall control.

This Intellectual Property Security Agreement and the rights and obligations of the parties hereunder shall be governed by, and construed in accordance with, the laws of the State of New York, without regard to principles of conflicts of laws thereof (other than Section 5-1401 of the General Obligations Law of the State of New York) that would result in the application of the laws of any other jurisdiction.
