ASSET PURCHASE AGREEMENT

This ASSET PURCHASE AGREEMENT (this “Agreement”) is entered into as of June 9, 2023, by and among AmeriMark Interactive, LLC, a Delaware limited liability company (“AI LLC”), each of the Subsidiaries of AI LLC set forth on Schedule I attached hereto (the “Seller Subsidiaries”, and together with AI LLC, “Sellers”), and Midwest Catalog Brands, LLC, a Wisconsin limited liability company (together with its permitted successors, designees and assigns, “Buyer”). Sellers and Buyer are referred to collectively herein as the “Parties.” Capitalized terms used but not otherwise defined herein shall have the meanings assigned to them in Article I.

WHEREAS, Sellers presently conduct the business of direct marketing and sales of merchandise (including apparel and footwear, furniture and home décor, general merchandise, health, beauty and wellness products and garden products) through a multi-channel platform across print catalogs, ecommerce websites and third-party marketplaces (collectively, the “Business”);

WHEREAS, on April 11, 2023 (the “Petition Date”), Sellers filed voluntary petitions for relief (the “Chapter 11 Cases”) pursuant to Chapter 11 of Title 11 of the United States Code, 11 U.S.C. §§ 101 *et seq.*, as amended (the “Bankruptcy Code”);

WHEREAS, Sellers desire to sell, transfer and assign to Buyer, and Buyer desires to acquire and assume from Sellers, pursuant to Sections 105, 363 and 365 of the Bankruptcy Code, the AMD Purchased Assets and the Assumed Liabilities upon the terms and subject to the conditions set forth herein;

WHEREAS, on the date hereof and simultaneously with the execution and delivery of this Agreement, as a condition to the Parties’ execution and delivery of this Agreement, Sellers are entering into that certain Asset Purchase Agreement, dated as of the date hereof, among AmeriMark Interactive, LLC, a Delaware limited liability company, each of the Subsidiaries of AI LLC set forth on Schedule I attached thereto, and LTD Buyer (as defined below) (such agreement, the “LTD Asset Purchase Agreement”), attached hereto as Exhibit E, pursuant to which the Sellers are agreeing to sell, transfer and assign to LTD Buyer their assets other than the AMD Purchased Assets, pursuant to the terms and conditions set forth in the SLR Asset Purchase Agreement.

WHEREAS, Sellers intend to seek the entry of the Sale Procedures Order by the United States Bankruptcy Court for the District of Delaware (the “Bankruptcy Court”) upon the terms and subject to the conditions set forth herein and in the Sale Procedures Order;

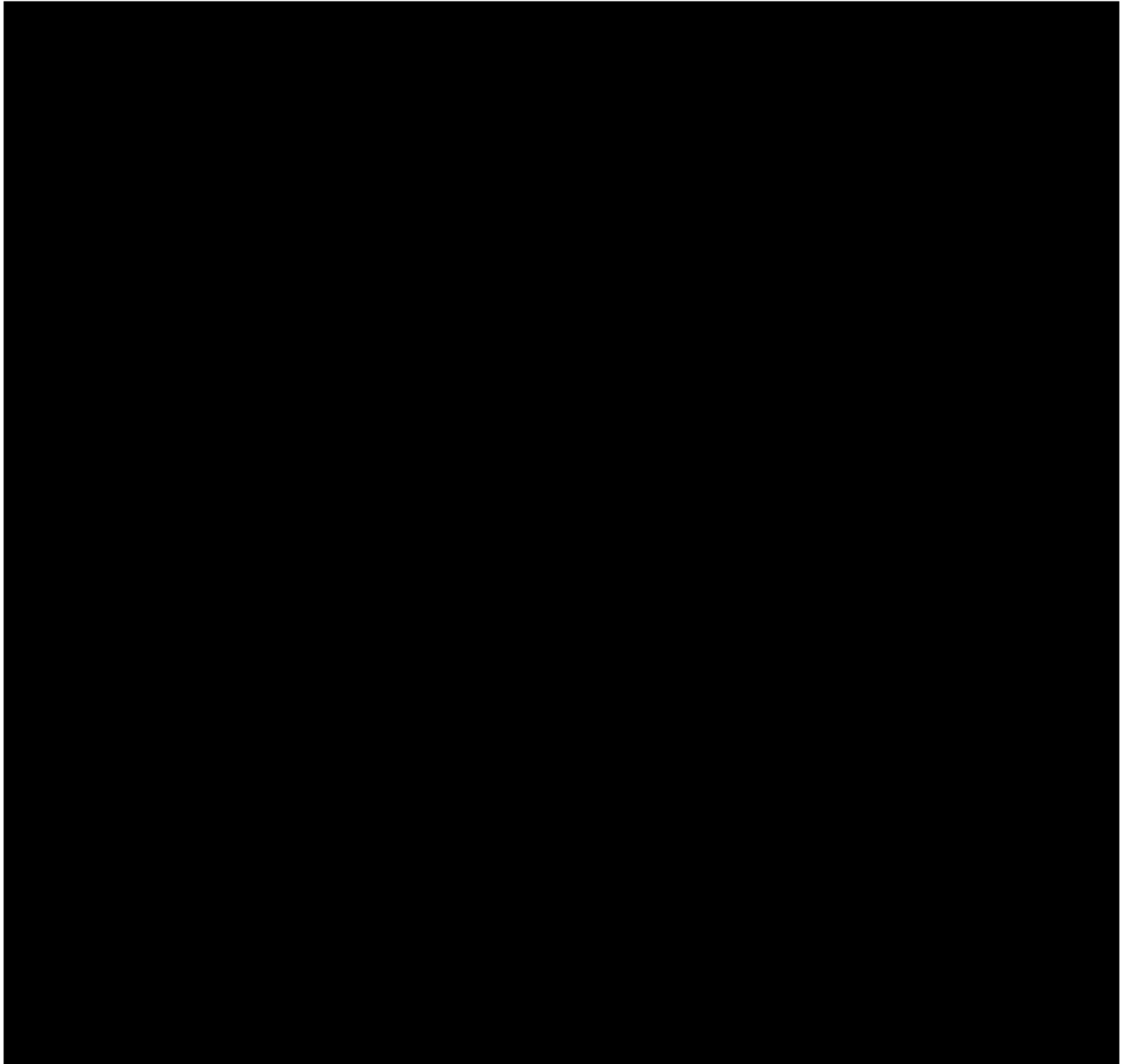
WHEREAS, Sellers intend to seek the entry of the Sale Order by the Bankruptcy Court approving this Agreement and authorizing Sellers to consummate the Contemplated Transactions upon the terms and subject to the conditions set forth herein and in the Sale Order;

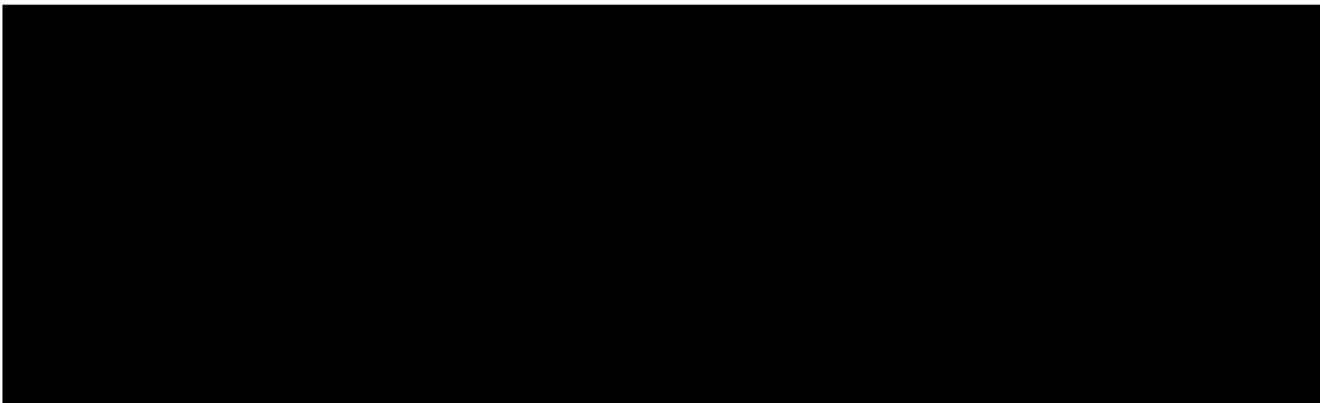
WHEREAS, the board of managers, the board of directors or other applicable governing body of each Seller has determined that it is advisable and in the best interests of their respective estates and the beneficiaries of such estates to consummate the Contemplated Transactions pursuant to the Sale Procedures Order and the Sale Order and has approved this Agreement, subject to higher or otherwise better offers as contemplated by the Sale Procedures Order; and

WHEREAS, the Contemplated Transactions are subject to the approval of the Bankruptcy Court, subject to higher or otherwise better offers as contemplated by the Sale Procedures Order, and will be consummated only pursuant to the Sale Order to be entered by the Bankruptcy Court.

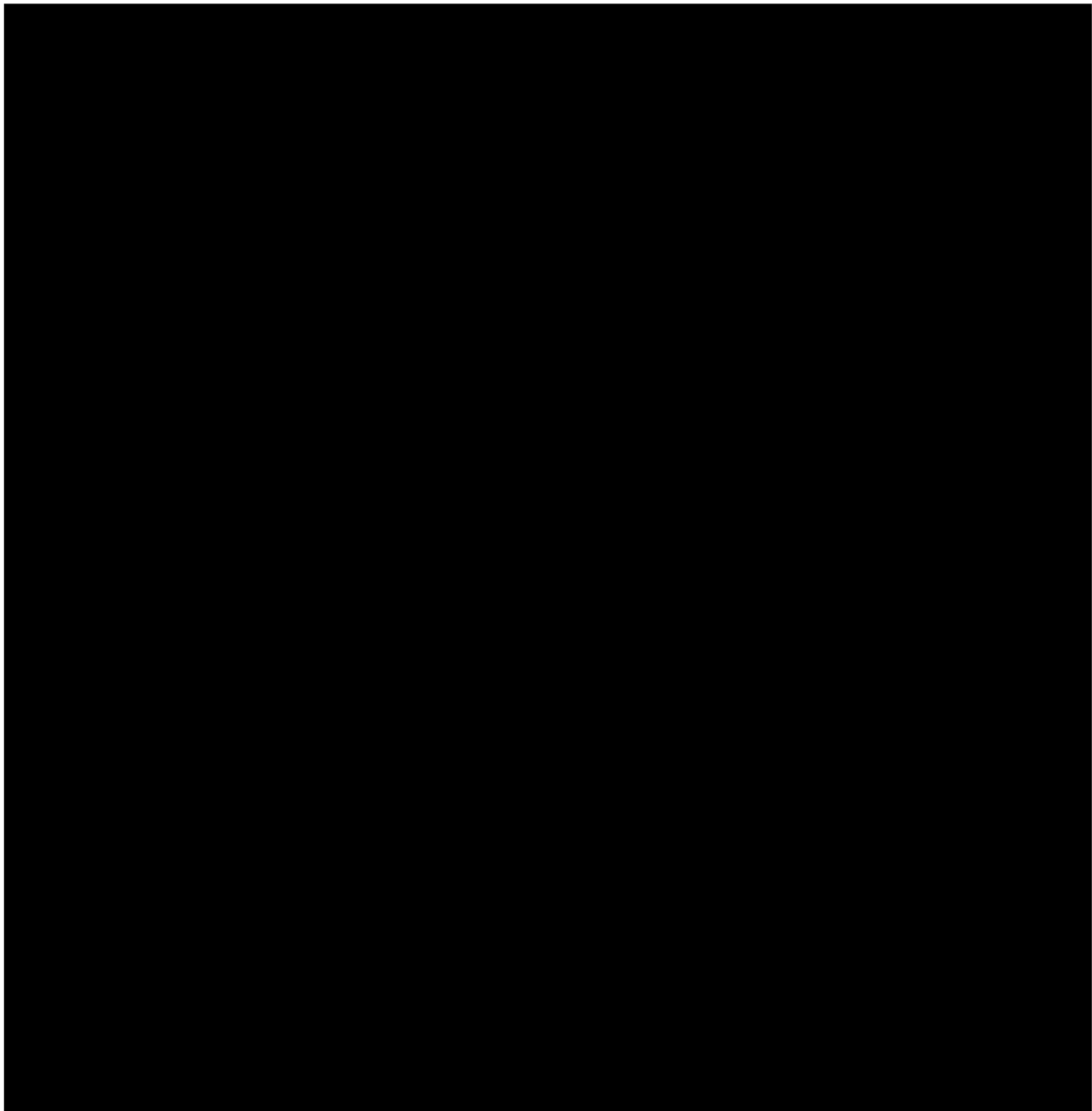

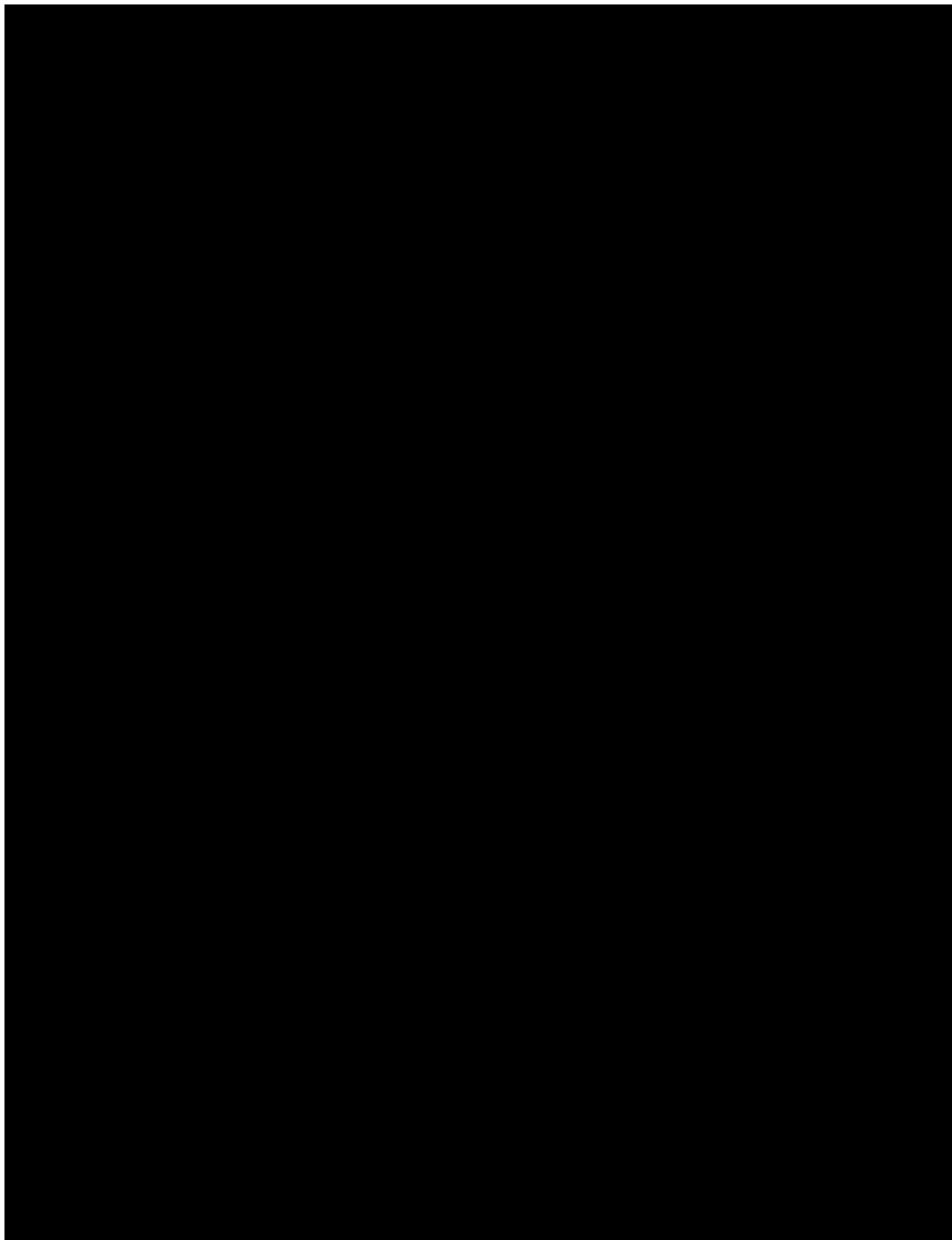


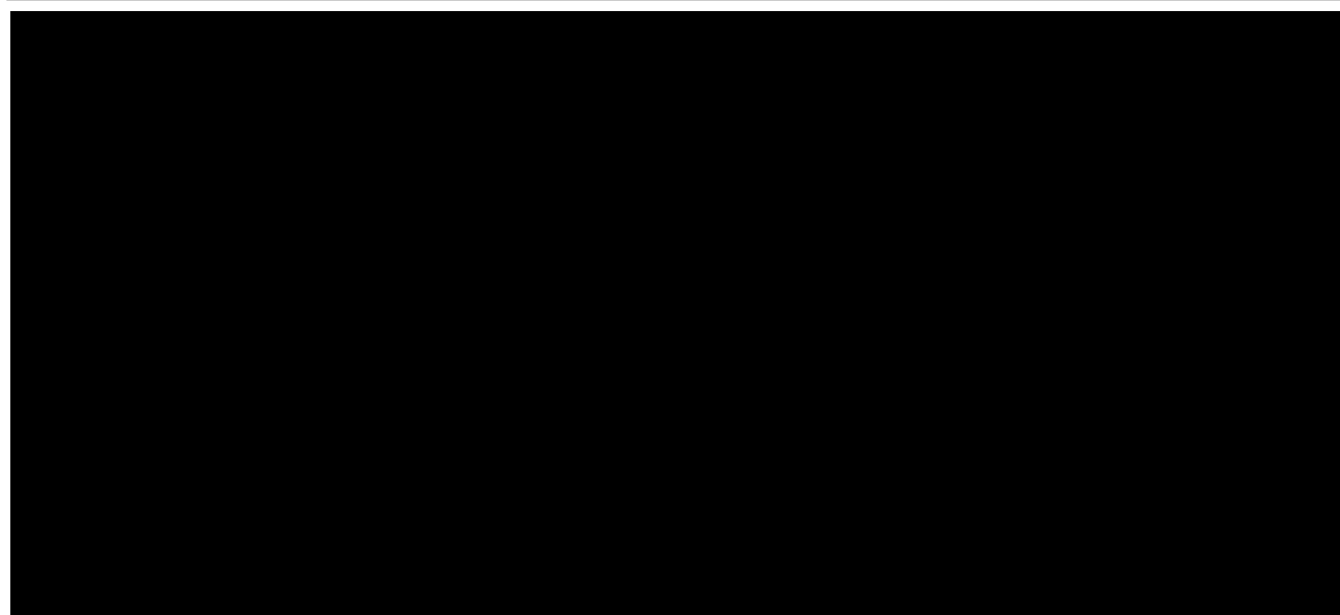
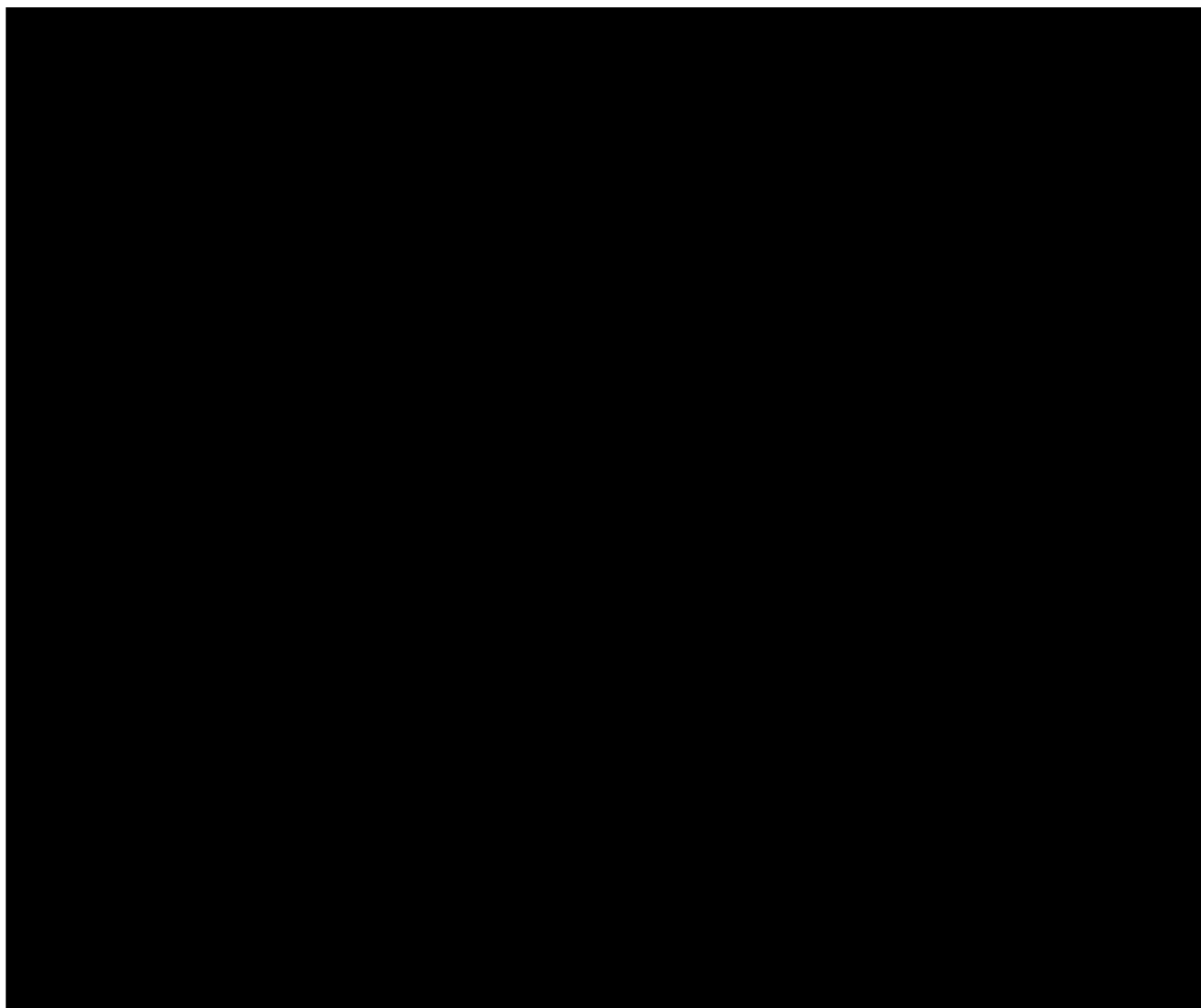


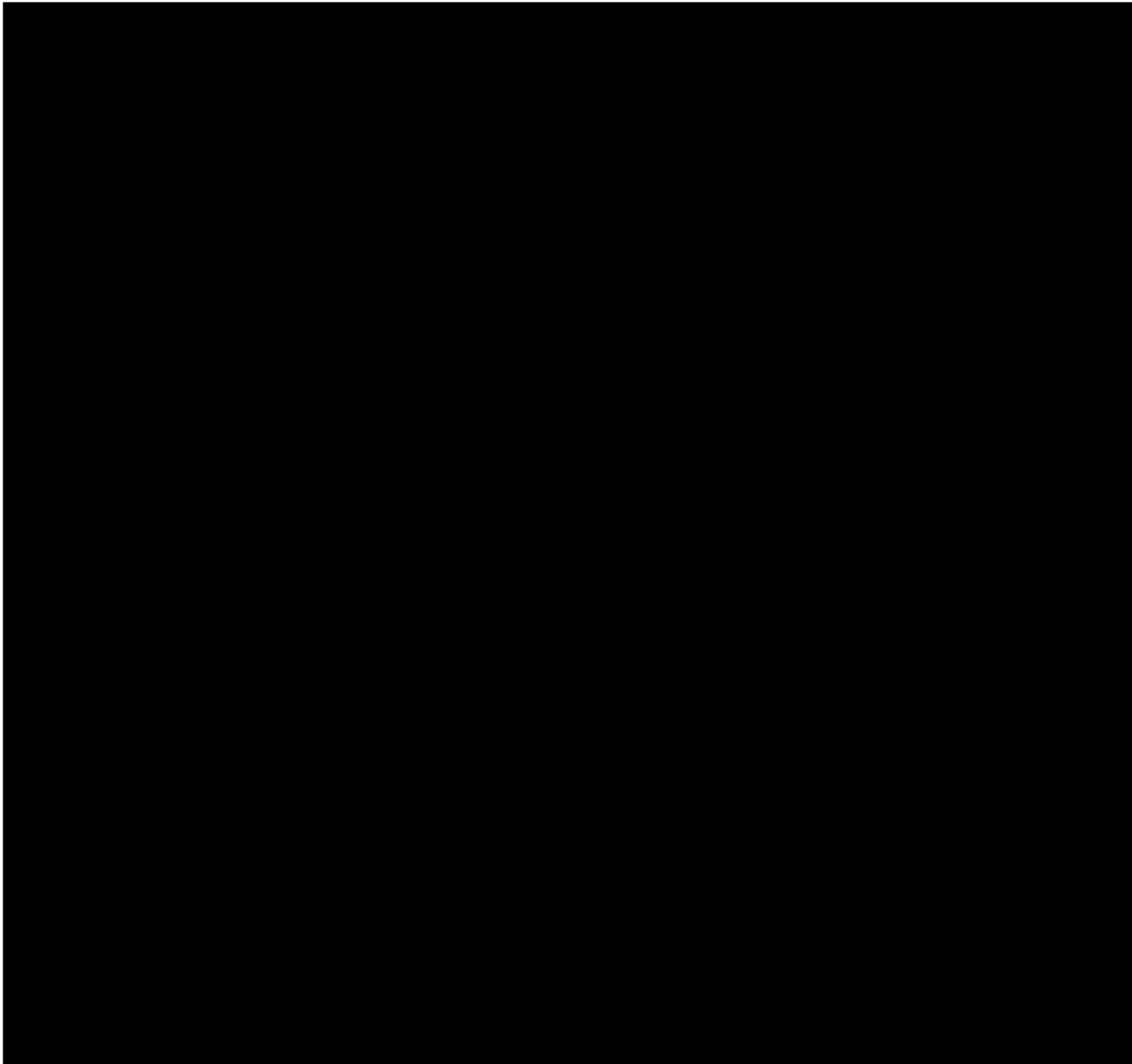










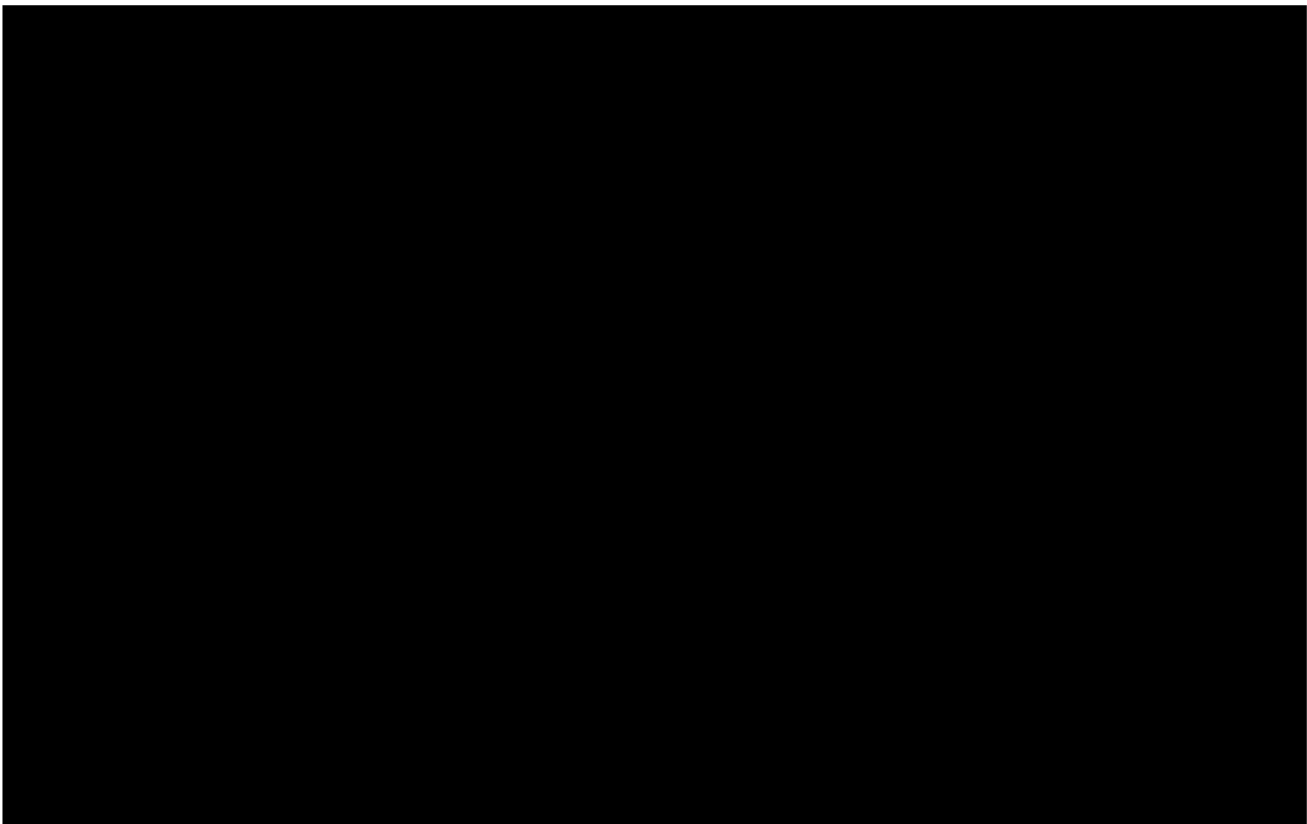


“Intellectual Property” means any and all right, title and interest in or relating to intellectual property of any type, which may exist or be created under the Laws of any jurisdiction throughout the world, including: (a) patents and patent applications, together with all reissues, continuations, continuations-in-part, divisionals, extensions and reexaminations in connection therewith; (b) trademarks, service marks, trade dress, logos, slogans, trade names, service names, brand names, Internet domain names, social media accounts and handles, and all other source or business identifiers and general intangibles of a like nature, along with all applications, registrations and renewals in connection therewith, and all goodwill associated with any of the foregoing; (c) rights associated with works of authorship, including exclusive exploitation rights, mask work rights, copyrights, database and design rights, whether or not registered or published, all registrations and recordings thereof and applications in connection therewith, along with all extensions and renewals thereof; (d) trade secrets, know-how, business information and technical information (including formulas, techniques and processes) and rights to limit the use or disclosure thereof by any Person; (e) computer software and firmware, including data files, source code, object code and

software-related specifications and documentation; (f) all other intellectual property rights related to the Business; and (g) all rights of action arising from any of the foregoing, including all claims for damages or equitable remedies by reason of present, past and future infringement or violation of the foregoing, all defenses relating to or arising from any of the foregoing, and all income, royalties and any other payments now and hereafter due or payable to a Seller in respect of the foregoing, provided that Intellectual Property shall not include Customer Data and Marketing Assets.

“Intellectual Property Agreements” means any and all agreements, permits, consents, orders and franchises relating to the license, development, use, or registration of any Intellectual Property included in the AMD Purchased Assets, including agreements pursuant to which (a) a Seller uses any Intellectual Property owned by any other Person (other than Commercially Available Software); (b) a Seller has been granted any license rights (including rights granted on a service basis) under any Intellectual Property owned by any other Person (other than Commercially Available Software); (c) a Seller has granted to any other Person any license rights under any Intellectual Property included in the AMD Purchased Assets (other than non-exclusive licenses granted by a Seller in the ordinary course of business in connection with the sale, lease or transfer of finished products or services); (d) any Intellectual Property is or has been developed by or for a Seller, assigned to a Seller by any other Person, or assigned by a Seller to any other Person; (e) a Seller settled any Intellectual Property related dispute; (f) a Seller restricted its exploitation of any Intellectual Property; or (g) a Seller agreed not to take legal action against a third party’s exploitation of the third party’s Intellectual Property.

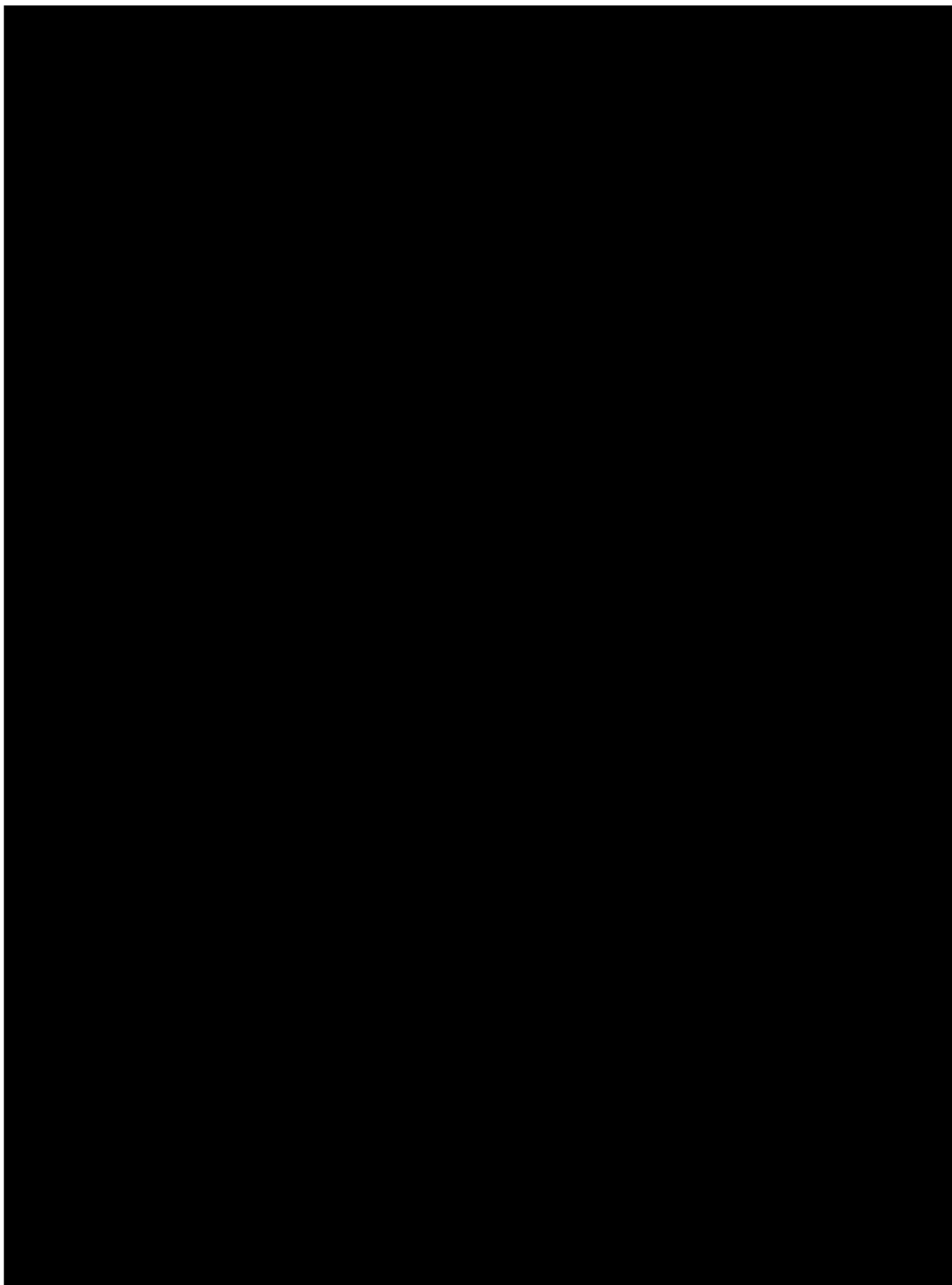

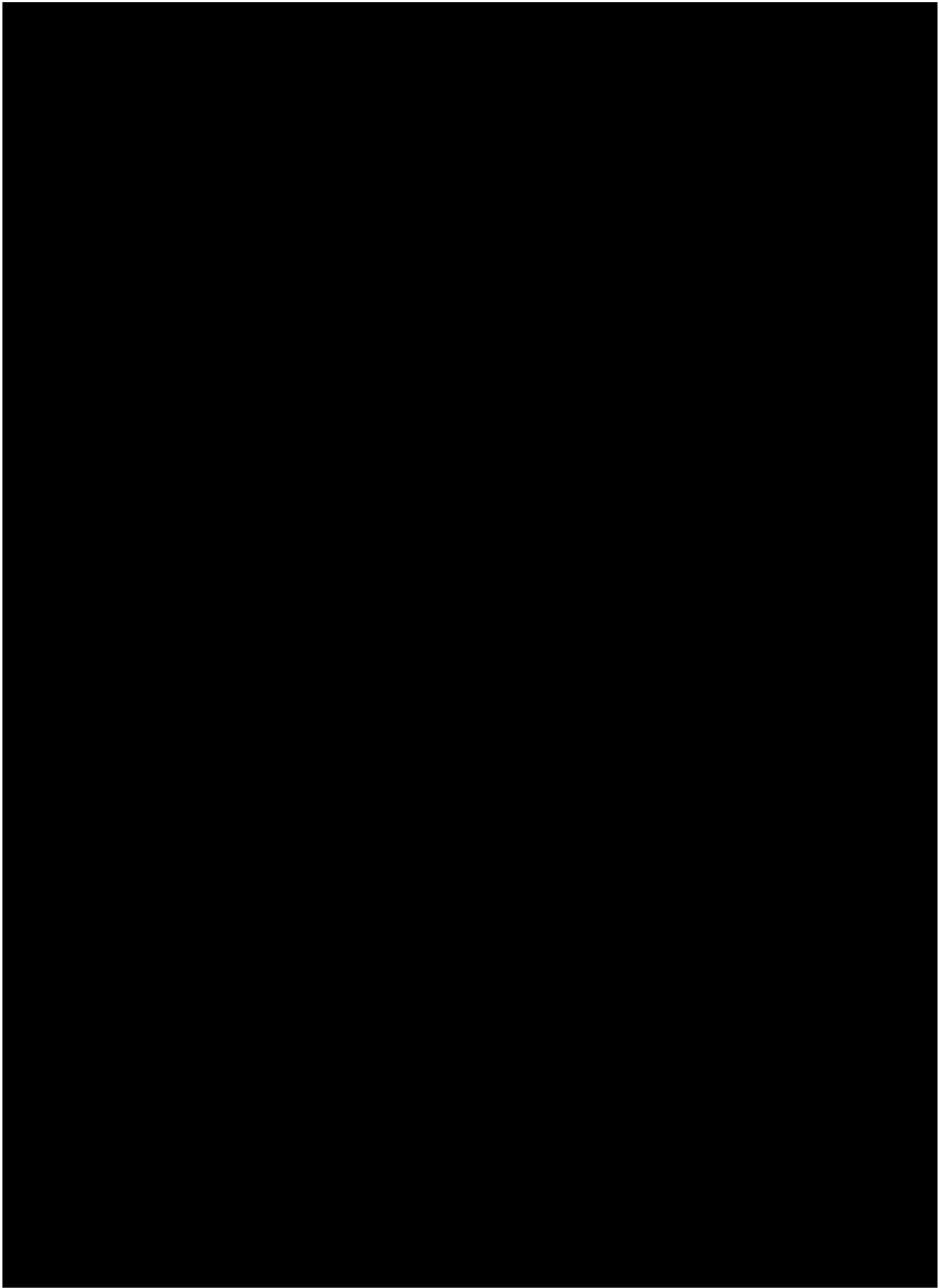

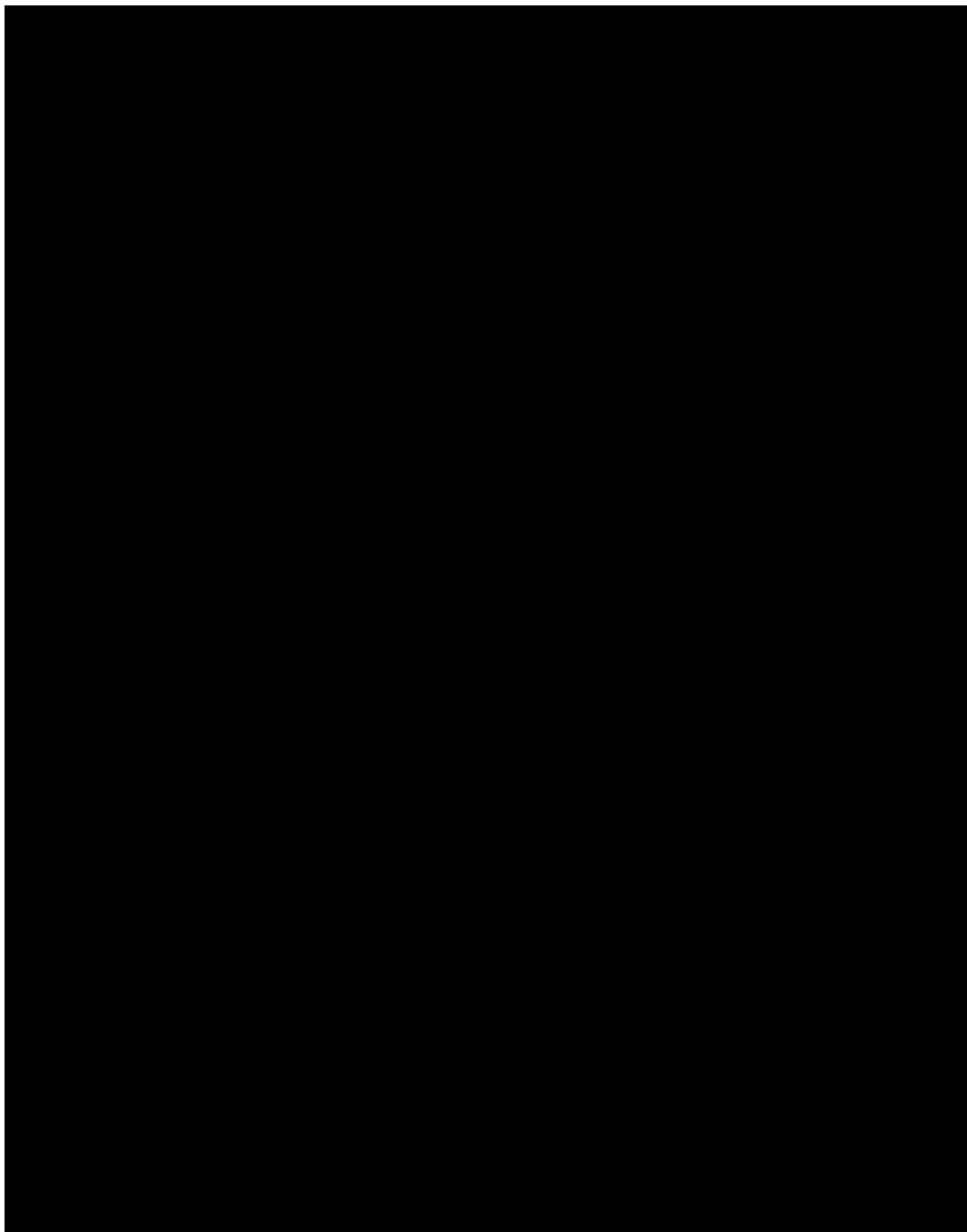

AmeriMark Holdings, LLC et al.*, Case No. N21C-12-175 (Delaware Superior Court), (B) *AmeriMark Interactive, LLC v. Bradshaw et al.*, Case No. 21L919 (Circuit Court, Lake County, Illinois), and (C) *AmeriMark Interactive, LLC, et al. v. LSC Communications MCL LLC, et al.*, Case Number 2022L008951, filed in the Circuit Court of Cook County, Illinois (the matters described in clauses (i) and (ii) above, the “Specified Litigation Matters”).

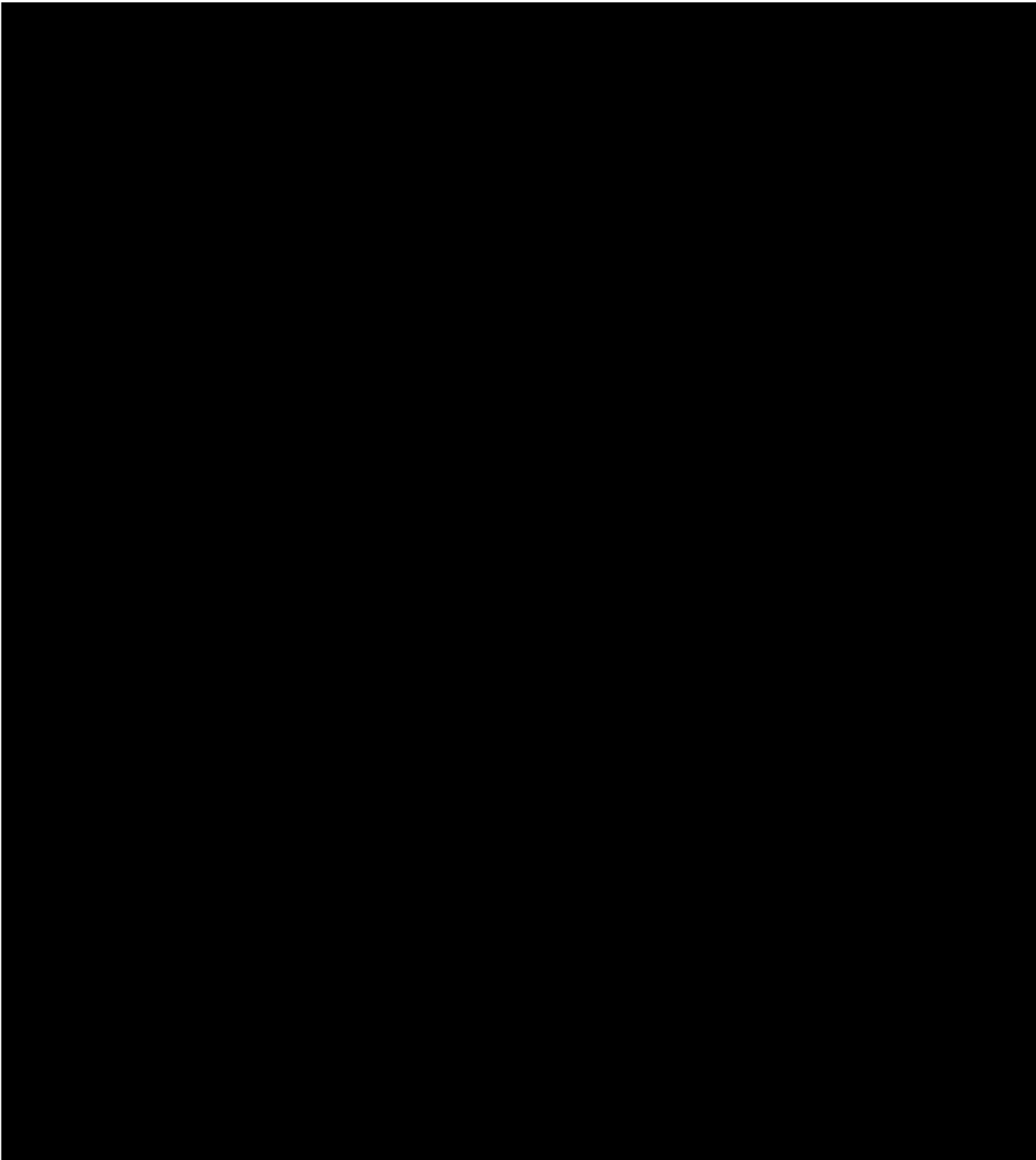

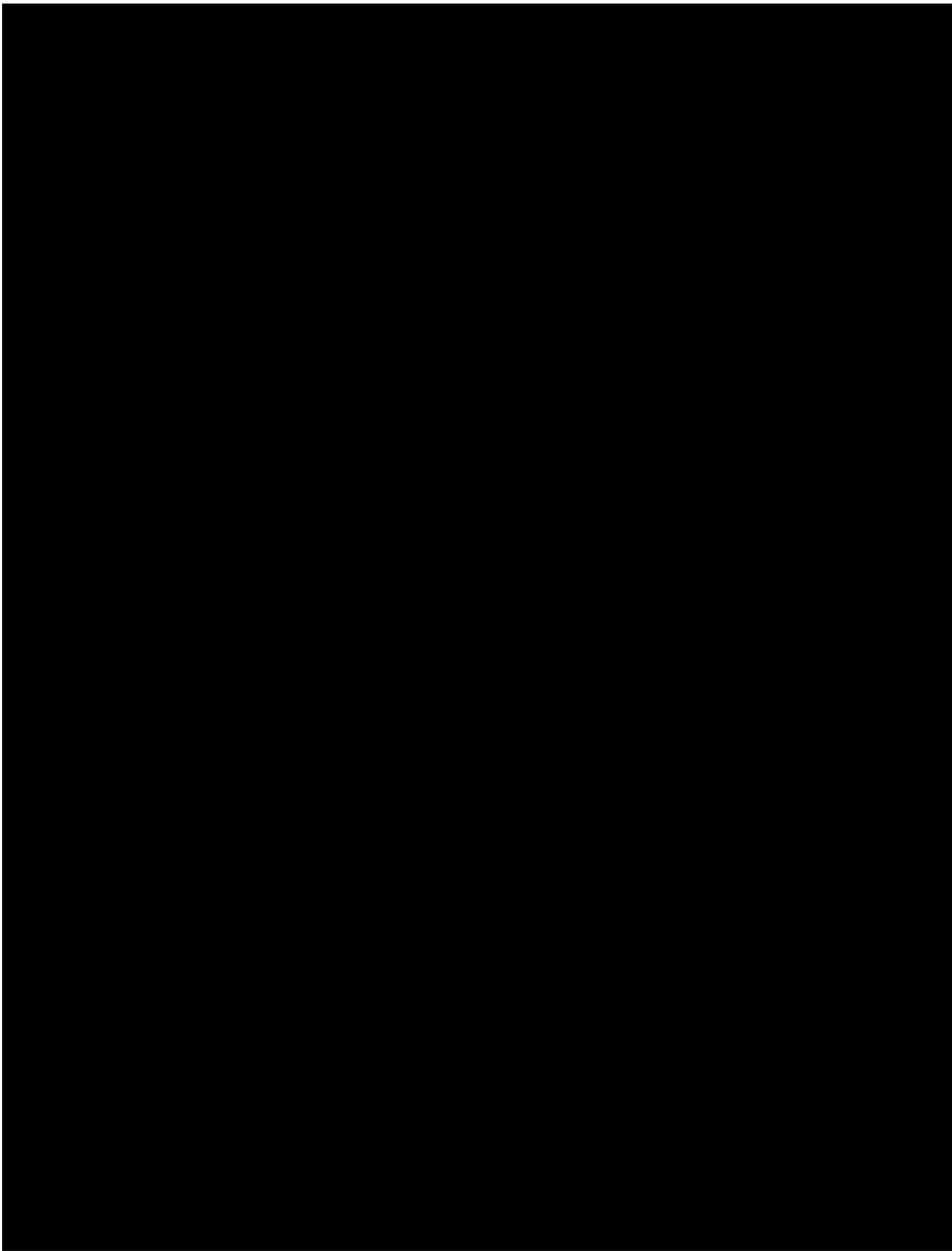


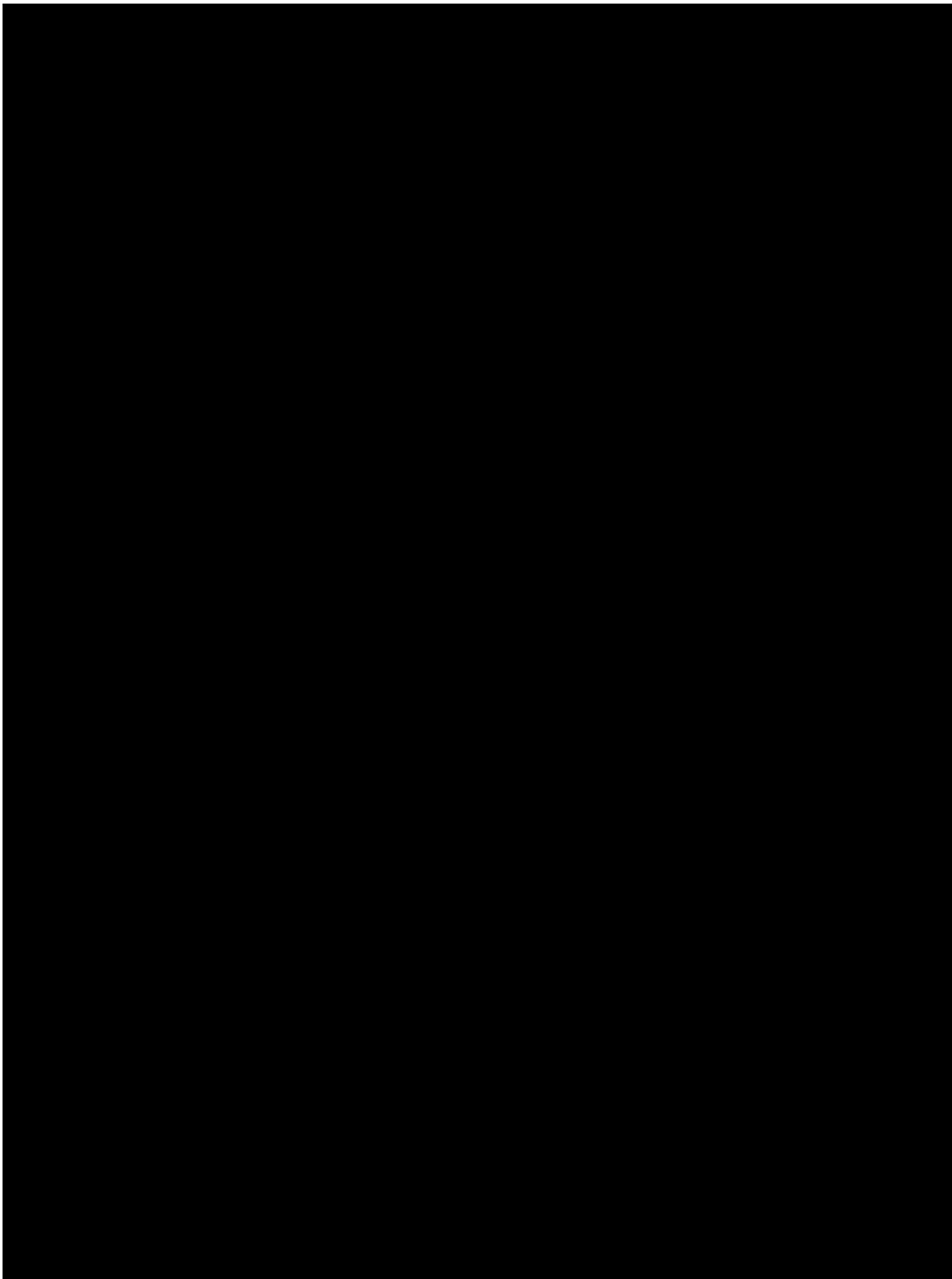

**ARTICLE II
PURCHASE AND SALE**

Section 2.1 Purchase and Sale of AMD Purchased Assets. Pursuant to Sections 105, 363 and 365 of the Bankruptcy Code, on the terms and subject to the conditions set forth in this Agreement, and in reliance upon the representations, warranties, covenants and agreements of the other Parties set forth in this Agreement, at the Closing, Buyer shall purchase, acquire and accept from Sellers, on an “as is, where is” basis and without any representation or warranty on the part of Sellers as to fitness, merchantability or otherwise (other than, in each case, as set forth in this Agreement or in the Related Agreements), and Sellers shall sell, transfer, assign, convey and deliver to Buyer, all of the AMD Purchased Assets, free and clear of all Liens (other than Permitted Liens and any Liens to the extent relating to or included in the Assumed Liabilities), for the consideration specified in Section 2.5. “AMD Purchased Assets” means all of the direct or indirect right, title and interest of Sellers in and to the following tangible and intangible assets, properties, rights, claims and Contracts of the Sellers as of the Closing :

- (a) all Accounts Receivable of Sellers associated with the AMD Brands and the LTD Brands;

(b) all Inventory of Sellers related to the AMD Brands, including all rights of Sellers to receive such Inventory, supplies and materials related to the AMD Brands which are on order (including such Inventory, supplies and materials located in the AMD Facilities or designated as being related to the AMD Brands in the Sellers' perpetual stock ledger or perpetual inventory system with respect to the AMD Brands, but excluding, for the avoidance of doubt, any Inventory to the extent related to the LTD Brands, even if such inventory is identical to that of the AMD Brands but for its branding or designation as LTD Brands Inventory in the Sellers' perpetual stock ledger or perpetual inventory system) (the "AMD Inventory");

(c) all Contracts with consumer customers of the Business regarding the extension of credit to such consumers or otherwise governing the terms of a credit relationship between a Seller and such consumer; provided, however, that no new credit may be advanced to any consumer under any Contract that makes reference to any of the LTD Brands or the LTD Business;

(d) all Assumed Contracts that have been assumed by, and assigned to, Buyer pursuant to Section 2.6;

(e) all Intellectual Property owned or purported to be owned, in whole or in part, by Sellers to the extent used or held for use in connection with the AMD Brands (the "AMD Intellectual Property"), including Intellectual Property reflected in the list of trademarks attached hereto as Annex 2.1(e)-1 and the list of domain names attached hereto as Annex 2.1(e)-2;

(f) Customer Data, to the extent used or held for use in connection with the AMD Brands; provided, however, that if any such Customer Data can only be accessed through a Transition Asset (such as purchase history for AMD Brands that can only be accessed through a server that is not located in an AMD Facility and is an LTD Purchased Asset), LTD Buyer shall provide to Buyer such Customer Data as promptly as possible after Closing, but in no event later than June 30, 2023;

(g) Marketing Assets, to the extent used or held for use in connection with the AMD Brands; provided, however, that if any such Marketing Assets can only be accessed through a Transition Asset (such as Google Analytics data that can only be accessed through a Google Analytics account that is an LTD Purchased Asset), LTD Buyer shall provide to Buyer such Marketing Assets as promptly as possible after Closing, but in no event later than June 30, 2023;

(h) to the extent used or held for use primarily in connection with the AMD Brands, all industrial and motor vehicles owned by Sellers;

(i) to the extent used or held for use primarily in connection with the AMD Brands, all items of machinery, equipment, supplies, furniture, fixtures, other personal property and leasehold improvements (to the extent of Sellers' rights to any leasehold improvements under the Leases that are Assumed Contracts) in connection with the AMD Brands and located at the AMD Facilities (the "Tangible Personal Property");

(j) other than Intellectual Property (which is addressed specifically in Section 2.1(e)), Customer Data (which are addressed specifically in Section 2.1(f)) and Marketing Assets (which are addressed specifically in Section 2.1(g)), all information technology assets, including

the Seller Information Systems and all Contracts related thereto, including the E-Commerce Platform or other seller platform, in each case that is used or held for use primarily with respect to the AMD Brands;

(k) to the extent used or held for use in connection with the AMD Brands, all five-digit UPC codes and customer service phone numbers;

(l) all Records (including Tax records, Tax Returns and personnel files and related information for all Transferred Employees) to the extent relating to the other AMD Purchased Assets, except for Excluded Records; provided, however, that such assets shall also be LTD Purchased Assets to the extent that they include information related to the other LTD Purchased Assets;

(m) all goodwill associated with the AMD Brands or the other AMD Purchased Assets, including all goodwill associated with the AMD Intellectual Property, the right to represent to third parties that Buyer is the successor to the Business with respect to the AMD Brands, all rights under any non-disclosure and confidentiality, noncompete, or nonsolicitation agreements with Current Employees or Former Employees, directors, independent contractors and agents of any Seller or with third parties for the benefit of any Seller, in each case to the extent relating to the AMD Brands, the other AMD Purchased Assets or the Assumed Liabilities (or any portion thereof);

(n) all of the Assumed Permits or all of the rights and benefits accruing under any Permits used or held for use primarily to the AMD Brands to the extent transferrable and held by Sellers;

(o) all other rights, demands, claims, credits, allowances, rebates or other refunds and rights in respect of promotional allowances or rights of setoff and rights of recoupment of every kind and nature (whether or not known or unknown or contingent or non-contingent), other than against Sellers, arising out of or relating solely to the other AMD Purchased Assets as of the Closing, including advances, prepayments and deferred assets (excluding, for the avoidance of doubt, those relating to the Specified Litigation Matters);

(p) except for the Chapter 5 Causes of Action and Excluded Claims, and solely with respect to other AMD Purchased Assets, all causes of action, lawsuits, judgments, claims, refunds, rights of recovery, rights of set-off, recoupment, counterclaims, defenses, demands, warranty claims, rights to indemnification, contribution, advancement of expenses or reimbursement, or similar rights of any Seller (at any time or in any manner arising or existing, whether choate or inchoate, known or unknown, now existing or hereafter acquired, contingent or noncontingent), if any, including all rights with respect to proofs of claim filed by or on behalf of any of Sellers in any bankruptcy case other than the Chapter 11 Cases (excluding, for the avoidance of doubt, those relating to the Specified Litigation Matters);

(q) all rights under or pursuant to all warranties, representations and guarantees made by suppliers, manufacturers, contractors and any other Person to the extent relating to equipment purchased, products sold, or services provided, to Sellers relating solely to the other

AMD Purchased Assets or the Assumed Liabilities (excluding, for the avoidance of doubt, those relating to the Specified Litigation Matters);

(r) to the extent not covered above in this Section 2.1, all of Sellers' telephone numbers, fax numbers, e-mail addresses, websites, URLs and internet domain names to the extent related to the other AMD Purchased Assets;

(s) the Fresh Finds Assets; provided, however, that (i) the Shared Fresh Finds Assets shall also be LTD Purchased Assets and LTD Buyer shall have control over such Shared Fresh Finds Assets; and (ii) LTD Buyer shall provide to Buyer a copy of the Shared Fresh Finds Assets as promptly as possible after Closing, but in no event later than June 30, 2023; and

(t) all other assets that are used or held for use solely in connection with the other AMD Purchased Assets or the AMD Brands and all tangible assets located at the AMD Facilities.

Section 2.2 Excluded Assets. Notwithstanding Section 2.1, Buyer expressly understands and agrees that Buyer is not purchasing or acquiring, and Sellers are not selling or assigning, any of the following assets, properties or rights of Sellers (the "Excluded Assets"):

(a) all Cash, including, for the avoidance of doubt, all Cash held in Sellers' cash management reserve account with PNC Bank N.A.;

(b) all Credit Card Receivables and Financing Company Receivables of Sellers and all deposits held by any credit card processors or related entities;

(c) all of Sellers' Fundamental Documents, qualifications to conduct business as a foreign entity, arrangements with registered agents relating to foreign qualifications, taxpayer and other identification numbers, seals, minute books, stock transfer books, unit certificates and other documents relating to the organization, maintenance and existence of any Seller as a limited liability company, corporation or other entity;

(d) all equity securities of any Seller or securities convertible into, exchangeable, or exercisable for any such equity securities and all net operating losses of any Seller;

(e) all Leases (and related leased real estate) and Contracts, in each case, other than the Assumed Contracts;

(f) all security deposits for rent, electricity, telephone, utilities or otherwise;

(g) all customer deposits, including deposits in transit, prepaid charges and expenses, credits, advance payments, charges and fees, associated with both the AMD Brands and the LTD Brands;

(h) the Excluded Claims and any applicable privilege, protection or immunity, including attorney-client privilege and the attorney work product doctrine, with respect to any Records relating thereto;

(i) any (i) personnel files for Current Employees and Former Employees of Sellers who are not Transferred Employees, (ii) Records containing confidential personal private information including confidential personnel and medical Records pertaining to any Current Employees or Former Employees to the extent the disclosure of such information is prohibited by applicable Law, (iii) other Records that Sellers are required by Law to retain, (iv) any Records or other documents of Sellers relating to the Chapter 11 Cases and Excluded Claims, including such Records and documents that are protected by the attorney-client privilege held by Sellers, and (v) any Records used in the operation of the LTD Business (collectively, the “Excluded Records”); provided, however, that Buyer shall have the right to make copies of any portions of such Excluded Records (other than the Records referenced in subsection (iv)) to the extent that such portions relate to any AMD Purchased Asset, including, if applicable, Records referenced in clauses (i) and (ii);

(j) all collective bargaining agreements or other Contracts purportedly entered into on behalf of any Employee by a representative of such Employee with the exception of any Assumed Contract expressly included in Section 2.6;

(k) all Permits other than the Assumed Permits;

(l) all directors’ and officers’ liability Insurance Policies, including any tail Insurance Policies, “representation & warranty” or “transaction risk” Insurance Policies and other similar Insurance Policies, all criminal acts Insurance Policies of Sellers of their Affiliates, and all rights of any nature with respect to any such Insurance Policies, including any recoveries or proceeds thereunder and any rights to assess claims seeking any such recoveries or proceeds (for the avoidance of doubt any and all Liabilities arising out of, or relating to, such insurance, including with respect to any underlying claims that give rise to claims seeking recovery in connection therewith constitute Excluded Liabilities);

(m) any assets expressly excluded from the AMD Purchased Assets pursuant to Section 2.1;

(n) all Employee Benefit Plans and trusts, as well as Insurance Policies, rights and other assets set aside and specifically reserved solely to fund benefits payable under the applicable Employee Benefit Plan;

(r) the Chapter 5 Causes of Action and any applicable privilege, protection, or immunity, including attorney-client privilege and the attorney work product doctrine, with respect to any Records relating thereto;

(s) the SLR Litigation Claims;

INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this “Assignment”) is made and entered into as of June 16, 2023 the “Effective Date”) by and among AmeriMark Interactive, LLC, a Delaware limited liability company (“AI LLC”), each of the Seller Subsidiaries (together with AI LLC, the “Assignors”), and Midwest Catalog Brands, LLC, a Wisconsin limited liability company (together with its permitted successors, designees and assigns, “Assignee”). Capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Asset Purchase Agreement, dated as of June 9, 2023, by and among Assignors and Assignee, as amended by that certain Amendment to Asset Purchase Agreement, dated as of June 15, 2023 (collectively, the “Asset Purchase Agreement”).

WHEREAS, pursuant to sections 105, 363 and 365 of the Bankruptcy Code, the Assignors and the Assignee have entered into the Asset Purchase Agreement, whereby, among other things, the Assignee has acquired the AMD Intellectual Property and the Intellectual Property related solely to the “Fresh Finds” brand (collectively, the “Assigned Intellectual Property”); and

WHEREAS, the Assignors desire to deliver to the Assignee such instruments of sale, transfer, assignment, conveyance and delivery as are required to vest in Assignee all of each of the Assignors’ right, title and interest in and to the Assigned Intellectual Property.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the Asset Purchase Agreement, the parties hereto, intending to be legally bound, hereby agree as follows:

1. Assignment. Each Assignor hereby forever sells, assigns, transfers, conveys and delivers to the Assignee and its successors and assigns, and the Assignee hereby accepts from each Assignor, free and clear of all Liens (other than Permitted Liens and Assumed Liabilities), all of each Assignor’s right, title and interest in, to and under the Assigned Intellectual Property, including the Intellectual Property listed on Schedule A and the domain names listed on Schedule B (the “Domain Names”).

2. Assignor’s Waiver. Each Assignor and the Assignee acknowledge and agree that as of the Effective Date all Assigned Intellectual Property is owned by the Assignee to the maximum extent permitted by Law. If any Assignor has any rights in or to any Assigned Intellectual Property that cannot, under applicable Law, be assigned to the Assignee or owned by the Assignee, each Assignor hereby unconditionally and irrevocably waives the enforcement of such rights and all claims and causes of action of any kind against the Assignee and their designees and successors and assigns with respect to such rights.

3. Further Assurances. After the Effective Date, each party shall, upon the reasonable request of the other, execute and deliver or cause to be executed and delivered such further instruments of sale, conveyance, assignment, transfer and assumption, and take such further action, as may reasonably be requested in order to more effectively carry out the purposes and intent of the Asset Purchase Agreement and this Assignment. Each Assignor agrees to effect the transfer of all Domain Names to the Assignee, including to electronically transfer the Domain Names from

each Assignor's account at their respective domain name registrars to Assignee's account (as designated by the Assignee) as quickly as reasonably practicable and executing and delivering any necessary documents to the Assignee, the registrars for the Domain Names, and any other party as requested by the Assignee and any of its successors and assigns.

4. Successors and Assigns. This Assignment shall be binding upon each Assignor and the Assignee, their respective successors and assigns, for the respective uses and purposes herein set forth and referred to, and shall be effective as of the Effective Date.

5. No Third Party Beneficiaries. No provision of this Assignment, express or implied, is intended or shall be construed to confer upon or give to any Person, other than the parties hereto and their respective successors and permitted assigns, any remedy or claim under or by reason of this Assignment or any term, covenant or condition hereof, and all of the terms, covenants, conditions, promises and agreements contained in this Assignment shall be for the sole and exclusive benefit of the parties hereto, and their respective successors and permitted assigns.

6. Severability. The provisions of this Assignment shall be deemed severable, and the invalidity or unenforceability of any provision of this Assignment shall not affect the validity or enforceability of any other provisions of this Assignment. If any provision of this Assignment, or the application thereof to any Person or any circumstance, is invalid or unenforceable, (a) a suitable and equitable provision shall be substituted therefor in order to carry out, so far as may be valid and enforceable, the intent and purpose of such invalid or unenforceable provision, and (b) the remainder of this Assignment and the application of such provision to other Persons or circumstances shall not be affected by such invalidity or unenforceability, nor shall such invalidity or unenforceability in any one jurisdiction affect the validity or enforceability of such provision, or the application thereof, in any other jurisdiction.

7. Modification and Waiver. None of the provisions of this Assignment may be amended or waived except if such amendment or waiver is in writing and is signed, in the case of an amendment, by each of the parties hereto, or in the case of a waiver, by the parties against whom the waiver is to be effective.

8. Interpretation. This Assignment is subject in all respects to the terms and conditions of the Asset Purchase Agreement. Nothing contained in this Assignment shall be deemed to supersede or modify any of the representations, warranties, covenants or other agreements contained in the Asset Purchase Agreement, all of which survive the execution and delivery of this Assignment as provided by, and subject to, the limitations set forth in the Asset Purchase Agreement. To the extent any provision of this Assignment is inconsistent with the Asset Purchase Agreement, the provisions of the Asset Purchase Agreement shall govern and control.

9. Governing Law. This Assignment shall in all aspects be governed by, and construed in accordance with, the internal Laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the Laws of any jurisdiction other than the State of Delaware, and the obligations, rights and remedies of the parties hereto shall be determined in accordance with such Laws. The parties hereto agree that any cause of action one party commences against any other party pursuant to this Assignment shall be brought exclusively in the Bankruptcy Court and

each of the parties hereby irrevocably consents to the jurisdiction of the Bankruptcy Court (and of the appropriate appellate courts therefrom) in any such suit, action or proceeding and irrevocably waives, to the fullest extent permitted by Law, any objection that it may now or hereafter have to the laying of the venue of any such suit, action or proceeding in the Bankruptcy Court or that any such suit, action or proceeding which is brought in the Bankruptcy Court has been brought in an inconvenient forum; provided that if the Bankruptcy Court is unwilling or unable to hear any such cause of action, then the courts of the State of Delaware, sitting in New Castle County, Delaware, and the federal courts of the United States of America sitting in New Castle County, Delaware, shall have exclusive jurisdiction over such cause of action.

10. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. This Assignment or any counterpart may be executed and delivered by facsimile or email with scan attachment copies, each of which shall be deemed an original.




