RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of August 8, 2023, by Agility Capital III, LLC, a California limited liability company ("Lender"), in favor of Health Without Walls Inc., a Delaware corporation ("Parent"), Nursing Without Walls, Inc., a Delaware corporation ("NWW"), Tender Health LLC, a California limited liability company ("THLLC"), Gento NJ, LLC, a New Jersey limited liability company ("Gento"), and UR Therapist Inc., a Delaware corporation ("URT"). WHEREAS, Grantors have no outstanding obligations to Lender under the Security Agreement, Lender agrees to release its security interest in the Intellectual Property.


Agreement
