rights hereby assigned to any third party; and that there are no actual or threatened claims, actions or proceedings against the Trademarks.

Assignor will, without additional consideration, take such further actions and execute promptly such further documents as are necessary or desirable to transfer, vest, record and perfect good, valid and marketable title to the Trademarks in Assignee. Assignor hereby authorizes Assignee to request that the applicable governmental entity record Assignee as the owner of the Trademarks with all applicable governmental authorities.
