RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS, dated as of August 29, 2023, is made by Zions Bancorporation, N.A., d/b/a Zions First National Bank (the "Lender") in favor of RST Brands, LLC, a Utah limited liability company (the "Grantor").

WHEREAS, Lender and the Grantor were parties to that certain Trademark Security Agreement, dated as of March 22, 2022 (the "Trademark Security Agreement"), pursuant to which the Grantor granted, collaterally assigned and pledged to Lender, security interest in all of the Grantor's right, title and interest in, to and under Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks listed on Schedule A attached hereto (the "Trademarks"); and

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office on March 29, 2022 at Reel 007673, Frame 0289; and

WHEREAS, all obligations of Grantor to the Lender under the Trademark Security Agreement have been fully satisfied and Grantor has requested, and Lender has agreed to provide, a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment, discharge and termination of Lender's security interest in, to and under the Trademark Collateral (the "Release").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby agrees as follows:

1. Defined Terms. All capitalized terms used in this Release but not expressly defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement.


2. Release of Security Interest. Lender, without representation, warranty or recourse, hereby terminates the Trademark Security Agreement and forever releases, relinquishes, terminates, cancels and discharges its security interest in the Trademark Collateral, including without limitation, its security interest in the Trademarks, and all applications, registrations and recordings thereof, as applicable, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of any infringement, misappropriation or other violation thereof and any and all damages arising from past, present and future infringements, misappropriations or other violations thereof.

3. Recordation. Lender hereby authorizes the Commissioner for Trademarks of the United States Patent and Trademark Office and any other governmental officials to record and register this Release.
