This Assignment is entered into to correct the Nunc Pro Tunc Trademark Assignment, dated July 22, 2008, that was recorded on August 4, 2008, at Reel 003828/Frame 0397-399. That document incorrectly identified the assignor as Oil States Skagit Smatco, Inc., a Louisiana corporation, which is an entity that did not exist in 2008 because Oil States Skagit Smatco, Inc. was merged into Oil States Skagit SMATCO, LLC, a Delaware limited liability company in 2001.
