RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of September 14, 2023, is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION (the “Bank”), in favor of AFFIGENT, LLC, an Alaska limited liability company, AKIMA, LLC, an Alaska limited liability company, NANA DEVELOPMENT CORPORATION, a corporation organized under the laws of the state of Washington and TRUESTONE, LLC, an Alaska limited liability company (each, a “Grantor” and, collectively, the “Grantors”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

RECITALS

A. WHEREAS, the Grantors have, pursuant to that certain Trademark Security Agreement, dated September 14, 2018, recorded in the United States Patent and Trademark Office (the “USPTO”) on October 5, 2018, at Reel 6451, Frame 0075 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Trademark Security Agreement”), granted to the Bank a security interest in all of each Grantor’s right, title and interest in and to the Trademark Collateral (the “Security Interest”), including without limitation those trademarks listed on Schedule A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, the Bank wishes to terminate and release its security interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Bank hereby terminates, extinguishes, cancels, discharges and releases, without recourse, any and all right, title and interest, including its Security Interest in and to the Released Collateral, terminates the Trademark Security Agreement and reassigns to the person or persons legally entitled thereto all rights, title and interest in the Released Collateral. The Bank authorizes the Grantors, or their designees, to record this Release with the USPTO and other applicable registry at the sole expense of the Grantors.

THIS RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT, TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE, AND THE RIGHTS AND DUTIES OF THE PARTIES HERETO, SHALL BE GOVERNED BY AND CONSTRUED AND DETERMINED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF NEW YORK AND APPLICABLE FEDERAL LAW.
