RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of September 21, 2023, is made by ARES CAPITAL CORPORATION, as administrative agent and collateral agent for the Lenders (in such capacity, the “Agent”) in favor of CAPITAL SPORTS & ENTERTAINMENT INC., an Ontario corporation (the “Grantor”). Capitalized terms used but not defined herein have the meanings given to them in the Trademark Security Agreement (as defined below), whether defined directly therein or by reference to another agreement.

WHEREAS, pursuant to that certain Grant of Security Interest in Intellectual Property, dated as of June 22, 2018, by and between the Grantor and the Agent (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “IP Security Agreement”), the Grantor executed and delivered in favor of the Agent that certain Trademark Security Agreement, dated as of June 22, 2018, which was recorded in the United States Patent and Trademark Office (“USPTO”) on June 26, 2018 at Reel/Frame 6364/0094 (the “Trademark Security Agreement”);

WHEREAS, pursuant to the IP Security Agreement and the Trademark Security Agreement, the Grantor assigned, mortgaged, pledged and granted to the Agent a continuing security interest (the “Security Interest”) in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule I hereto; and

WHEREAS, the Grantor has requested that the Agent terminate and release its Security Interest in the Trademark Collateral.


NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates and cancels the IP Security Agreement and the Trademark Security Agreement, (ii) terminates, cancels, discharges and releases its Security Interest in the Trademark Collateral and (iii) releases and re-assigns to the Grantor any right, title or interest it may have in or to the Trademark Collateral, in each case without recourse to the Agent and without representation or warranty of any kind.

The Grantor (and any successor to the Grantor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral) is hereby authorized to record this Release with the USPTO.
