## CONFIRMATORY TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") dated as of May 26, 2023 (the "Effective Date") is between Neeva, Inc., a Delaware corporation with an address of Suite 3A, 106 E. WHEREAS, Assignor is the owner of all right, title and interest in and to the Trademarks described on Schedule A attached hereto (the "Trademarks") and all of the goodwill of the business associated therewith;

WHEREAS, for good and valuable consideration and pursuant to a certain Agreement and Plan of Merger dated May 26, 2023, in which the Assignor became the wholly owned subsidiary of the Assignee ("Merger Agreement"), and upon the terms and conditions set forth below, Assignee has acquired all rights, title and interest in and to said Trademarks as of May 26, 2023;

NOW THEREFORE, in consideration of the transactions contemplated by the Merger Agreement and this Assignment and of other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby assigns, grants, transfers and otherwise conveys to Assignee, its successors and assigns, its entire right, title and interest in and to said Trademarks, including but not limited to all of Assignor's common law rights and registrations pertaining thereto, as well as all of the goodwill of the business symbolized by said Trademarks, including without limitation, the right to any registrations thereof, the right to prosecute any applications therefor, the right to have any registrations issue in the name of the Assignee, the right to apply for and obtain any renewal of any registrations thereof, the right to any priorities based on the filing of the aforesaid applications, the right to sue for past and future infringement.
2. Further Assurances. At the reasonable request of either party and without further consideration, the other party shall execute and deliver such other instruments of assignment and assumption and take such other actions as may be necessary to affect the intent of this Assignment.
