## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT ("Trademark Assignment"), is made this 23rd day of September, 2023 by Longstreth Sporting Goods, LLC ("Assignor"), a Pennsylvania limited liability company having a business address at 78 Wells Road, Spring City, Pennsylvania 19475, in favor of Longstreth Sporting Goods, LLC ("Assignee"), a Delaware limited liability company having a business address at 78 Wells Road, Spring City, Pennsylvania 19475.

WHEREAS, Assignor applied for the "LONGSTRETH" trademark application (Serial Number 97409839) on or about May 13, 2022, wherein Assignor's applicant name was incorrectly identified as a Pennsylvania limited liability company notwithstanding that the state of formation of Assignor is Delaware;

WHEREAS, the LONGSTRETH trademark was registered on July 4, 2023 under the US Registration Number 7097622 (the "Trademark");

WHEREAS, the administrative error noted above was recently discovered by Assignor, and Assignor desires to correct the record for the Trademark registration and the United States Patent and Trademark Office ("USPTO") records; and


WHEREAS, in order to correct such record, the USPTO is requiring Assignor and Assignee to enter into this Trademark Assignment, notwithstanding that Assignor and Assignee are the same legal entity.

NOW THEREFORE, the parties hereto agree as follows:


1. **Assignment.** For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of the Assignor's right, title, and interest in and to the following:
  - a. the Trademark and all issuances, extensions and renewals thereof;
  - b. all rights of any kind whatsoever of the Assignor accruing under the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;
  - c. any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
  - d. any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. **Recordation and Further Actions.** Assignor hereby authorizes the Commissioner for Trademarks in the USPTO to record and register this Trademark Assignment. Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to the Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Trademarks to the Assignee, or any assignee or successor thereto.
3. **Counterparts.** This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.
4. **Successors and Assigns.** This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
