**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of September 26, 2023, (this "Release") is made by JPMorgan Chase Bank, N.A., as Administrative Agent, ("Administrative Agent") under the Trademark Security Agreement (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement"), among Markwins Beauty Products, Inc., a California corporation, (the "Debtor") and the Administrative Agent. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded at the United States Patent and Trademark Office on June 16, 2021 at Reel 7327 and Frame 0938, the Debtor granted to the Administrative Agent a continuing security interest in all of Debtor's right, title and interest in Trademarks, including those set forth on the attached Schedules A & B, together with the goodwill of the business symbolized by Debtor's Trademarks.

WHEREAS, Debtor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Released Collateral, and (d) reassign, grant and convey to Debtor any and all right, title and interest it has in the Released Collateral.
