**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

WHEREAS, by that certain Intellectual Property Security Agreement dated December 8, 2016 ("Security Agreement"), originally recorded in the Trademark Assignment Branch of the United States Patent and Trademark Office ("PTO") by that certain Notice of Grant of Security Interest in Intellectual Property on December 28, 2016 at Reel/Frame 5952/0445, Zapzyt Holdings LLC, a Delaware limited liability company with an address at 801 Broad Street, Suite 600, Chattanooga, Tennessee 37402 ("Grantor"), granted to Pinnacle Bank, a Tennessee banking corporation, with a mailing address of 801 Broad Street, Suite 100, Chattanooga, Tennessee 37402, ("Bank"), a continuing security interest in and continuing lien upon the Grantor's trademarks, services marks and related registrations and applications (the "Trademarks"), together with the goodwill and assets of the business symbolized by such Trademarks and all actions for infringement concerning the foregoing including the right to sue for and to recover and retain all damages and profits arising from past infringements, identified in the attached Schedule A;
