**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of September 28, 2023, by **DEUTSCHE BANK AG NEW YORK BRANCH**, a German banking corporation, in its capacity as administrative agent and as collateral agent (in such capacities, together with its successors and assigns in such capacities, “Administrative Agent”) in favor of **THE BAZOOKA COMPANIES, INC.**, a Delaware corporation with an address at One Whitehall Street, New York, New York 10004 (the “Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Security Agreement (each as defined below), as applicable.

W I T N E S S E T H:

WHEREAS, the Grantor is a party to a Security Agreement dated as of February 1, 2022 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Security Agreement”) in favor of the Administrative Agent.

WHEREAS, pursuant to the Security Agreement, the Grantor entered into a certain Trademark Security Agreement dated as of February 1, 2022 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Trademark Security Agreement”) with the Administrative Agent, notice of which was recorded on February 2, 2022 by the United States Patent and Trademark Office at Reel 7603, Frame 0544.

WHEREAS, under the terms of the Trademark Security Agreement, the Grantor collaterally assigned and pledged to the Administrative Agent, its successors and permitted assigns, for the benefit of the Secured Parties, and granted the Administrative Agent, its successors and permitted assigns, for the benefit of the Secured Parties and their permitted successors and assigns, a continuing security interest in, and lien on (collectively, the “Security Interest”) all of such Grantor’s right, title and interest in any and all of the following (in each case, other than any Excluded Assets) (collectively, the “Trademark Collateral”) of the Grantor:

- (a) registered Trademarks and Trademark applications of the Grantor set forth in **Schedule A** attached hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by the foregoing;
- (d) any and all claims for damages and injunctive relief for past, present and future infringement, misappropriation, violation or misuse with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- (e) any and all Proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, all products of, and supporting obligations relating to, any and all of the Trademark Collateral of or arising from any of the foregoing.

WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest in and on all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby permanently and irrevocably releases, cancels, terminates and discharges the Security Interest in and on the Trademark Collateral, including any and all of its right, title and interest in the Trademark Collateral, and re-assigns, re-transfers and re-conveys to the Grantor all of its right, title, or interest in the Trademark Collateral. Any right, title or interest of the Administrative Agent in the Trademark Collateral shall hereby cease and become void.

The Administrative Agent hereby terminates and cancels the Trademark Security Agreement.

The Administrative Agent hereby agrees, upon the reasonable request and at the sole expense of the Grantor, to deliver such further documents and do such other acts as may be reasonably necessary to effectuate the release of the Security Interest in the Trademark Collateral contemplated hereby. The Administrative Agent hereby authorizes and requests that the United States Patent and Trademark Office record this Trademark Release.


