RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of September 28, 2023 (the “Effective Date”), is made by Ares Capital corporation, in its capacity as Collateral Agent (the “Collateral Agent”), in favor of Commercial Trailer Leasing, Inc. (the “Grantor”).

WHEREAS, pursuant to that certain Pledge and Security Agreement (First Lien), dated as of January 19, 2021, by and among the Collateral Agent and the Loan Parties party thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Collateral Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered that certain Notice of Grant of Security Interest in Trademark, dated as of January 19, 2021 (the “Trademark Security Agreement (First Lien)”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement (First Lien) was recorded with the United States Patent and Trademark Office on January 27, 2021 at Reel/Frame 7170/0957;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement (First Lien), as applicable.

2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the trademark collateral, including the trademark registration and application set forth on Schedule A attached hereto, the goodwill of the business symbolized by the trademark and the application and registration thereof, and all proceeds thereof (collectively, the “Trademark”), arising under the Security Agreement and the Trademark Security Agreement (First Lien). If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark under the Trademark Security Agreement (First Lien), the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement (First Lien).


4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to the Grantor and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the state of New York, without regard to conflicts of law or choice of law principles.
