RELEASE AND REASSIGNMENT OF TRADEMARKS

This **RELEASE AND REASSIGNMENT** is made this 29th day of September 2023 by **ADVANTAGE CAPITAL CONNECTICUT PARTNERS I, LIMITED PARTNERSHIP**.

W I T N E S S E T H :
