REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest (this “*Reassignment and Release*”) is made as of September 29, 2023, by WESTERN ALLIANCE BANK, an Arizona corporation (“*Bank*”) in favor of INTERACTIVE DIGITAL SOLUTIONS, LLC, a Delaware limited liability company (“*Grantor*”).

RECITALS

WHEREAS, Grantor is a co-borrower under that certain Loan and Security Agreement (as amended, the “*Loan Agreement*”) dated as of August 31, 2022, by and among, inter alios, the Bank, BCP MEDSITTER HOLDCO, INC., a Delaware corporation, COLLETTE HEALTH, LLC, a Delaware limited liability company and BCP IDS HOLDCO, INC., a Delaware corporation (“*IDS Holdco*”);

WHEREAS, Grantor granted to Bank a security interest in its copyrights, patents and trademarks (collectively, the “*Intellectual Property Collateral*”), under an Intellectual Property Security Agreement dated as of August 31, 2022 (as may be amended, restated, supplemented or otherwise modified, the “*Security Agreement*”). All capitalized terms used in this Reassignment and Release and not otherwise defined herein have the meaning given in the Security Agreement.

Whereas, pursuant to that certain letter agreement dated as of even date herewith, by among, inter alios, the Bank, BCP MEDSITTER HOLDCO, COLLETTE HEALTH, LLC, IDS Holdco, and Grantor, the Bank has consented to the release of each of IDS Holdco and the Grantor as co-Borrowers under the Loan Agreement and each of the Loan Documents (as defined in the Loan Agreement), and acknowledges and agrees that all guarantees, security interests and other liens of every type at any time granted by IDS Holdco and/or Grantor to Bank as security shall be deemed terminated, released and discharged as of the date hereof, and all other obligations owed by each of IDS Holdco and Grantor to the Bank under the Loan Agreement and the Loan Documents shall be deemed terminated as of the date hereof;

WHEREAS, Grantor has no outstanding obligations to Bank under the terms of the Loan Documents and Security Agreement, and Bank agrees to release its security interest in the Intellectual Property Collateral.

AGREEMENT

Now therefore, Bank terminates, discharges, cancels, and releases its security interest in the Intellectual Property Collateral and reassigns to Grantor, without warranty or recourse, all interest of Bank in the Intellectual Property Collateral. Bank hereby terminates, without representation or warranty of any kind, the Security Agreement.
