INTELLECTUAL PROPERTY SECURITY INTEREST ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY SECURITY INTEREST ASSIGNMENT AGREEMENT (this "Agreement") dated as of July 20, 2018 is by and among COÖPERATIEVE RABOBANK U.A., NEW YORK BRANCH ("Rabobank"), in its capacity as the resigning Administrative Agent and Collateral Agent (in such capacity, "Resigning Agent"), COBANK, ACB ("CoBank"), in its capacity as the successor Administrative Agent and Collateral Agent (in such capacity, "Successor Agent"), and the Borrowers identified on the signature pages hereto.

WHEREAS, the Resigning Agent was Administrative Agent and Collateral Agent under that certain Third Amended and Restated Credit Agreement (as amended, modified and supplemented from time to time, the "Credit Agreement") dated as of May 8, 2017 and entered into by and among Pilgrim's Pride Corporation, a Delaware Corporation, To-Ricos, Ltd., a Bermuda company, and To-Ricos Distribution, Ltd., a Bermuda company (collectively, the "Borrowers"), and the Lenders parties thereto;

WHEREAS, pursuant to the Resignation and Appointment of Agent Agreement dated as of July 20, 2018 ("2018 Resignation Agreement"), Rabobank resigned as Administrative Agent and Collateral Agent, and CoBank was appointed as successor Administrative Agent and Collateral Agent;

WHEREAS, Rabobank, as Resigning Agent, is presently the holder of certain security interests in the intellectual property included in the Collateral (the "IP Collateral"), such security interests having been granted or assigned to Rabobank from time to time pursuant to certain security agreements and assignment agreements, including the agreements identified on Schedule 1 (the "IP Security Agreements").

WHEREAS, in connection with the 2018 Resignation Agreement, Rabobank desires to assign all of its right, title and interest in and to the IP Collateral to CoBank.

NOW, THEREFORE, in consideration of the mutual and dependent promises and undertakings set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the parties hereto hereby covenant and agree as follows:

1. Defined Terms. Capitalized terms used herein and not defined herein shall have the meanings assigned to such terms in the Credit Agreement and other Loan Documents and the IP Security Agreements.

2. Assignment. The Resigning Agent irrevocably transfers, assigns, grants, and conveys, without any representation, warranty or recourse, to the Successor Agent all of the Resigning Agent's right, title and interest in and to the IP Collateral, including, without limitation, the IP Collateral identified on Schedules 2-4 hereto, the IP Security Agreements, all security interests in the IP Collateral arising under the Loan Documents, and all security interest filings and notices relating to the IP Collateral associated with the Loan Documents, together with any rider, addendum, exhibit, schedule and attachment thereto.

3. Cooperation. The Credit Parties and the Resigning Agent hereby authorize the Successor Agent to record this Agreement amending the name of the secured party in the IP Security Agreements to CoBank, ACB, as Administrative Agent.

4. Successors and Assigns. This Agreement is binding upon, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.

5. No Novation. The parties hereto agree that this Agreement shall not constitute an amendment to any of the Loan Documents and shall not constitute a novation in any manner whatsoever.

6. Expenses. The Borrowers agree to promptly reimburse the Resigning Agent and the Successor Agent for all expenses (including fees and expenses of counsel) incurred in connection with this Agreement.

7. Counterparts: Delivery. This Agreement may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original and it shall not be necessary in making proof of this Amendment to produce or account for more than one such counterpart. Delivery of an executed counterpart of this Agreement by facsimile or other electronic imaging means shall be effective as an original.

8. Governing Law. This Agreement shall be deemed to be a contract made under, and for all purposes shall be construed in accordance with, the laws of the State of New York.
