REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of September 29, 2023, by **WESTERN ALLIANCE BANK**, an Arizona corporation ("**Bank**") and **HEALTH-ADE LLC**, a Delaware limited liability company ("**Grantor**"), and made with reference to the Loan and Security Agreement, dated as of February 28, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "**Loan Agreement**"), between Bank and Grantor. Capitalized terms not otherwise defined herein shall have the meaning ascribed to such terms in the Loan Agreement.

Recitals

WHEREAS, under that certain Intellectual Property Security Agreement, dated as of February 28, 2020, between Bank and Grantor (the "**Security Agreement**"), Grantor granted to Bank a security interest in its copyrights, patents and trademarks, including without limitation, its copyrights described on Exhibit A, its trademarks described on Exhibit B and its patents described on Exhibit C, and recorded with the US Patent and Trademark Office as set forth on Exhibit B (collectively, the "**Intellectual Property Collateral**").

WHEREAS, Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, and Bank agrees to release its security interest in the Intellectual Property Collateral.


Agreement

Now therefore, Bank agrees that it terminates and releases its security interest in all of Grantor's right, title and interest in, to and under Grantor's Intellectual Property Collateral and reassigns to Grantor, without warranty or recourse, all interest of Bank in the Intellectual Property Collateral.
