RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "Release") is made as of September 29, 2023 ("Effective Date") by **CADENCE BANK f/k/a CADENCE BANK, N.A.**, a national banking association having an office at 3399 Peachtree Road, N.E., Suite 1800, Atlanta, GA 30326 ("Lender"), in favor of **DUNN TIRE LLC**, a Delaware limited liability company having its principal place of business at 475 Cayuga Road, Suite 500, Buffalo, New York 14225 (the "Company").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, dated November 6, 2020 (the "Security Agreement"), the Company assigned, transferred and conveyed to Lender a security interest in all of the Company's rights, title and interests in and to the collateral listed on Schedule A hereto (the "Collateral");

WHEREAS, a notice of security interest with respect to the Collateral and the Security Agreement was recorded with the United States Patent and Trademark Office on November 12, 2020 at Reel 7104, Frame 0188; and

WHEREAS, Lender has consented to the release of the lien and of its interests in the Collateral;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby covenants and agrees as follows:

1. Lender hereby terminates and releases any and all of its liens on and security interests in the Collateral.
2. To the extent Lender retains any such interest, Lender hereby assigns, transfers and conveys to the Company, all of Lender's rights, title and interests, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Collateral.
3. Lender hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release.
