TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 29, 2023 (“Release”), is made by Corrum Capital Big Bear, LP (f/k/a Corrum Capital Global Credit Opportunities Co-Investment Fund I, L.P.), as Collateral Agent (“Collateral Agent”) in favor of New Form Digital, LLC, a Delaware limited liability company (“Borrower”).

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of September 4, 2019 (as amended, restated, amended and restated, extended, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Borrower, Collateral Agent, and others party thereto, Borrower granted to the Collateral Agent, for the ratable benefit of itself and Lenders, a security interest in any and all right, title and interest of Borrower in and to all Trademarks, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Borrower executed and delivered to Collateral Agent the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on September 5, 2019 at Reel 6736 Frame 0830 (“Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of itself and Lenders, and Borrower agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Collateral Agent, on behalf of itself and Lenders, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in any and all right, title and interest of Borrower in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Borrower’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
