RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of October 3, 2023 (the "Effective Date") in favor of RELCO, LLC, a Minnesota limited liability company ("Grantor"), by WELLS FARGO BANK, NATIONAL ASSOCIATION, a National Banking Association ("Administrative Agent").

WHEREAS, Administrative Agent and PW ACQUISITION, L.L.C. (n/k/a PW Stoelting, L.L.C.), a Wisconsin limited liability company ("PW Stoelting") entered into that certain Trademark Security Agreement dated May 21, 2012 (the "Security Agreement"), and recorded with the United States Patent and Trademark Office (the "USPTO") on June 6, 2012, at Reel 4797, Frame 0413, pursuant to which PW Stoelting granted to Administrative Agent a security interest in all of its right, title and interest in, to and under certain intellectual property, including the trademark listed on the attached Exhibit A (the "Trademark").

WHEREAS, PW Stoelting and Grantor entered into that certain Intellectual Property Assignment dated October 19, 2012, and filed in the USPTO on October 26, 2012, at Reel 004889, Frame 0375, pursuant to which the Trademark were assigned by PW Stoelting to Grantor.

WHEREAS, Administrative Agent has agreed to release its liens on the Trademark pursuant to this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby (a) terminates the Security Agreement, (b) terminates, cancels and releases any and all security interests it has against the Trademark, and (c) re-assigns to Grantor any right, title and interest it may have in, to and under the Trademark to Grantor.

This Release shall be governed by and construed in accordance with the laws of the State of Minnesota.
