1. The name and jurisdiction of the constituent companies to the Merger (as defined below) are as follows:

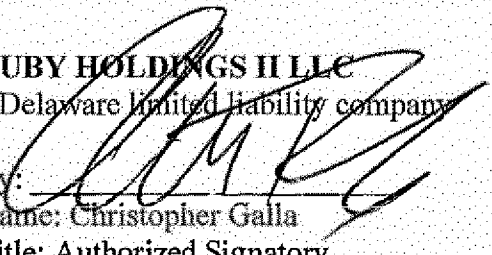
