**PARTIAL TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Partial Termination and Release of Security Interest in Trademarks (“Release”) is made as of October 2, 2023, by **OWL ROCK CAPITAL CORPORATION**, a Maryland corporation (in such capacity, together with its successors and assigns, “Collateral Agent”) in favor of **ONPOINT GROUP, LLC**, a Delaware limited liability company with an address at 3235 Levis Common Boulevard, Perrysburg, Ohio 43551 (“Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated July 21, 2021 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on July 21, 2021 at the United States Patent and Trademark Office at Reel 7361, Frame 0277.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of such Grantor’s right, title and interest in and to the Trademark Collateral, including the trademarks listed in **Schedule A**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest solely in the Trademark Collateral listed in **Schedule A** as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest solely in the Trademark Collateral listed in **Schedule A**, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
