**PARTIAL RELEASE OF TRADEMARKS TO  
GRANT OF A SECURITY INTEREST - TRADEMARKS**

This Partial Release of Trademarks to Grant of a Security Interest - Trademarks dated as of October 2, 2023 (this "***Partial Release***") is made with regard to that certain Grant of a Security Interest - Trademarks entered into as of August 17, 2022 by and between **SC – BCP Acquisition Company, LLC**, a Delaware limited liability company ("***Grantor***") and **Gladstone Capital Corporation**, a Maryland corporation, as Agent ("***Grantee***").

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee forever releases and discharges the entire security interest in and to certain trademarks and trademark applications set forth on Schedule A attached hereto.

Grantee hereby agrees to execute such instruments, to take such other actions, and to give such further assurances as the Grantor reasonably shall request to terminate any security interest in certain trademarks and trademark applications pursuant to the Grant of a Security Interest - Trademarks and otherwise to effectuate the release of all recordations of such security interest in certain trademarks and trademark applications.

Grantee acknowledges and agrees that the Grantor and its successors and assigns may rely upon this Partial Release. Grantee represents and warrants that it has not transferred or assigned all or any part of the security interest in the certain trademarks and trademark applications to any third party, and that it has all necessary authority to execute this Partial Release and grant the releases and discharges and all other rights set forth herein.
