# NOTICE OF PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This NOTICE OF PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Partial Release"), made as of September 29, 2023, is made by JPMORGAN CHASE BANK, N.A., as the administrative agent and collateral agent (in such capacity, the "Agent") for each of the Secured Parties (as such term is defined in the Credit Agreement referred to below), in favor of HBI BRANDED APPAREL ENTERPRISES, LLC, a Delaware limited liability company (the "Grantor").

## <u>W I T N E S S E T H</u>:

WHEREAS, pursuant to (i) the First Lien Credit Agreement, dated as of September 5, 2006 and Amended and Restated as of December 10, 2009 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement"), among Hanesbrands, Inc., a Maryland corporation (the "Borrower"), JPMorgan Chase Bank, N.A., as the Administrative Agent and the Collateral Agent, and the other Lenders and parties party thereto, (ii) the Pledge and Security Agreement, dated as of September 5, 2006 and as amended and restated as of December 10, 2009 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Security Agreement") among the Grantor, the other grantors party thereto, and the Agent, and (iii) that certain Amended and Restated Trademark Security Agreement, dated as of December 10, 2009 (the "Trademark Security Agreement"), among the Grantor and the Agent, the Grantor granted to the Agent, for its benefit and the ratable benefit of each Secured Party, a continuing security interest (the "Security Interest") in all of the Grantor's right, title and interest, whether then or thereafter existing or acquired by the Grantor, in the Trademark Collateral (as such term is defined in the Trademark Security Agreement), including without limitation those Trademarks referred to on Item A of Schedule I attached thereto:

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 15, 2009 at Reel/Frame No. 4114/0398;

WHEREAS, the Trademark Collateral included, among other things, all of the Grantor's right, title and interest to and under the Trademarks of the Grantor listed on <u>Schedule</u> A attached hereto (the "Released Trademark Collateral"); and

WHEREAS, the Grantor has requested that the Agent provide this Partial Release in order to terminate and release its Security Interest solely in the Released Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

SECTION 1. <u>Definitions</u>. Unless otherwise defined herein, terms used in this Partial Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement or the Trademark Security Agreement, as applicable.

- SECTION 2. Release of Security Interest in Released Trademark Collateral. The Agent, without recourse, representation or warranty of any kind, hereby terminates, releases, discharges, and cancels its Security Interest in the Released Trademark Collateral arising under the Trademark Security Agreement and the Security Agreement, and any right, title or interest of the Administrative Agent in the Released Trademark Collateral arising under the Trademark Security Agreement or the Security Agreement shall hereby cease and become void.
- SECTION 3. <u>Partial Release</u>. This Partial Release is applicable only and solely with respect to the Released Trademark Collateral and to no other Trademark Collateral arising under the Trademark Security Agreement or the Security Agreement. Except as expressly modified hereby, the Trademark Security Agreement and the Security Agreement shall remain in full force and effect, each in accordance with the provisions thereof on the date thereof.
- SECTION 4. <u>Recordation.</u> The Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Partial Release.
- SECTION 5. Governing Law. This Partial Release shall be deemed to be a contract made under and governed by the internal laws of the State of New York (including for such purpose Sections 5-1401 and 5-1402 of the General Obligations Law of the State of New York), except to the extent that the perfection, effect of perfection or nonperfection, and priority of the security interest hereunder, or remedies hereunder, in respect of any particular collateral are governed by the laws of a jurisdiction other than the State of New York.
